# VARIABLE-STEP 4-STAGE HERMITE-BIRKHOFF SOLVER OF ORDER 9 AND 10 FOR STIFF ODES

Abstract. Variable-step (VS) 4-stage $k$-step Hermite-Birkhoff (HB) methods of order $p=(k+2), p=9,10$, denoted by $\operatorname{HB}(p)$, are constructed as a combination of linear $k$-step methods of order $(p-2)$ and a diagonally implicit one-step 4-stage Runge-Kutta method of order 3 (DIRK3) for solving stiff ordinary differential equations. Forcing a Taylor expansion of the numerical solution to agree with an expansion of the true solution leads to multistep and Runge-Kutta type order conditions which are reorganized into linear confluent Vandermonde-type systems. This approach allows us to develop $L(\alpha)$-stable methods of order up to 10. Fast algorithms are developed for solving these systems in $\mathrm{O}\left(p^{2}\right)$ operations to obtain HB interpolation polynomials in terms of generalized Lagrange basis functions. The stepsizes of these methods are controlled by a local error estimator. $\operatorname{HB}(p)$ of order $p=9$ and 10 compare favorably with existing Cash modified extended backward differentiation formulae of order 7 and $8, \operatorname{MEBDF}(7-8)$, in solving problems often used to test higher order stiff ODE solvers on the basis of number of steps and error at the endpoint of the integration interval.

## 1. Introduction

In this paper, we shall be concerned with solving stiff systems of first-order ordinary differential equations of the form

There is a variety of variable step (VS) methods designed to solve nonstiff and stiff systems of first-order differential equations (ODEs). Gear advocated a quasiconstant step size implementation in DIFSUB [13]. This software works with a constant step size until a change of step size is necessary or clearly advantageous. Then a continuous extension is used to get approximations to the solution at previous points in an equally spaced mesh. This was largely because constant mesh spacing is very helpful when solving stiff problems. Another possibility is fixed leading coefficient, which is seen in Petzold's popular code DASSL [22]. Finally, the actual mesh can be chosen by the code as done in MATLAB's ode113. This is the equivalent of a PECE Adams formula in contrast with the Adams-Moulton formulas of DIFSUB and DASSL. In this paper, a fully variable step size implementation is used with actual mesh. A brief survey of methods for the numerical integration of (1) reveals that many of the advances in the class of general linear multistep methods for stiff ODEs, methods like extended backward differentiation formula (EBDF), modified extended backward differentiation formula (MEBDF), adaptive extended backward differentiation formula (AEBDF) and hybrid backward differentiation formula (HBDF) [5, 6, 7, 8, 15, 9], are based on backward differentiation formula (BDF). These methods are A-stable or $\mathrm{A}(\alpha)$-stable. The first modification introduced by Cash [5] was the EBDF in which one superfuture point has been applied.

In this paper, methods with four off-step points are presented. A linear $k$ step method of order $p-2$ and a diagonally implicit one-step 4 -stage Runge-Kutta method of order 3 (DIRK3) are cast into a $k$-step 4 -stage Hermite-Birkhoff method of order $p=k+2$, named $\operatorname{HB}(p), p=9,10$, because it uses Hermite-Birkhoff interpolation polynomials, for solving stiff ordinary differential equations (ODE) (1). Here, the DIRK3 is defined in Section 2 with $p=3$ and step number $k=1$. This method is similar to the diagonally implicit one-step Runge-Kutta methods (DIRK) found in [1] except that, following the approach of Cash [5], the abscissae $c_{i}$ are allowed to be $0 \leq c_{i} \leq 2, i=2,3,4$. The methods which we shall derive will be observed to require more work per step, but to have higher orders of accuracy and better stability characteristics, than existing methods.

Forcing a Taylor expansion of the numerical solution of $\mathrm{HB}(p)$ methods to agree with an expansion of the true solution leads to multistep and Runge-Kutta type order conditions which are reorganized into linear Vandermonde-type systems. The solutions of these systems are obtained as generalized Lagrange basis functions by new fast algorithms.

It was found experimentally that, generally, increasing the number of backstep points is efficient in increasing the accuracy of HB methods and the stability of HB methods increases with the number of off-step points. The $\operatorname{HB}(p)$, considered here,
are $L(\alpha)$-stable methods of order up to 10 .
It was also found that, with a given fixed number of off-step points, increased speed is generally achieved by higher order HB methods.
$\operatorname{HB}(p), p=9,10$ compare favorably with $\operatorname{MEBDF}(p), p=7,8,[5,6]$ on problems often used to test higher order ODE solvers for stiff ODEs on the basis of the number of steps and the error at the endpoint of the interval of integration. In Section 2, we introduce new general VS $\mathrm{HB}(p)$ methods of order $p$. Order conditions of general VS $\mathrm{HB}(p)$ are listed in Section 3. In Section 4, particular variable step $\mathrm{HB}(p), p=9,10$ are defined by fixing a set of parameters and are represented in terms of Vandermonde-type systems. In Section 5, symbolic elementary matrices are constructed as functions of the parameters of the methods in view of factoring the coefficient matrices of Vandermonde-type systems. Fast solution of Vandermondetype systems for particular variable step $\operatorname{HB}(p)$ is constructed in Section 6. Section 7 considers the regions of absolute stability of constant step $\mathrm{HB}(p), p=3,4, \ldots, 10$. Section 8 deals with the step control. In Section 9, we compare the numerical performance of the methods considered in this paper. Appendix A lists the algorithms. Appendix B lists the coefficients of DIRK3 and constant step $\operatorname{HB}(p)$ methods of order $p=4,5, \ldots, 10$.

## 2. General variable step $\operatorname{HB}(p)$ of order $p$

General 4-stage HB methods are constructed, as a subclass of general linear methods, by the following four formulae to perform integration from $t_{n}$ to $t_{n+1}$.

Let $h_{n+1}$ denote the step size. The abscissa vector $\left[c_{1}, c_{2}, \ldots, c_{5}\right]^{T}$ defines the off-step points $t_{n}+c_{j} h_{n+1}$ with $c_{1}=0$ and $c_{5}=1$. Following the approach of Cash [5], $c_{i}$ are allowed to be $0 \leq c_{i} \leq 2, i=2,3,4$.

Let $F_{1}=f_{n}$ and $F_{j}:=f\left(t_{n}+c_{j} h_{n+1}, Y_{j}\right), j=2,3,4,5$, denote the $j$ th stage derivative.

With the initial stage value, $Y_{1}=y_{n}$, HB polynomials of degree $k+i-1$ are used as predictors $\mathrm{P}_{i}$ to obtain the stage values $Y_{i}$ to order $p-2$,

An HB polynomial of degree $k+3$ is used as implicit integration formula IF to obtain $y_{n+1}$ to order $p$,

An HB polynomial of degree $k+3$ is used as implicit predictor $\mathrm{P}_{5}$ to control the stepsize, $h_{n+2}$, and obtain $\widetilde{y}_{n+1}$ to order $p-2$,

Here, the forms (2)-(3) are used by the implicit algebraic equations system defining $Y_{i}, i=2,3,4$ and $y_{n+1}$ to handle implicitness in the context of stiffness.

The distinct implicit algebraic equations systems (2)-(3) defining $Y_{i}, i=2,3,4$ and $y_{n+1}$ are solved exactly sequentially.

The following terminology will be useful. An $\operatorname{HB}(p)$ method is said to be a general variable-step HB method if its backstep, off-step points and the coefficients

in (2)-(3) are variable parameters. Hence, the general variable-step HB method has five degrees of freedom $\left(c_{2}, c_{3}, c_{4}, a_{22}=a_{33}=a_{44}=b_{5}, a_{32}\right)$. If the off-step points and the coefficients in (5) are fixed, the method is said to be a particular variablestep method. If the stepsize is constant, and hence the backsteps, off-steps and the coefficients in (5) are fixed parameters, the method is said to be a constant-step method.

## 3. Order conditions of general $\mathrm{HB}(p)$

To derive the order conditions of 4 -stage ( $p-2$ )-step $\mathrm{HB}(p)$, we shall use the following expressions coming from the backsteps of the methods:

In the sequel, $\eta_{j}$ will be frequently used without explicit reference to (7).
Forcing an expansion of the numerical solution produced by formulae (2)-(3) to agree with the Taylor expansion of the true solution, we obtain multistep- and several RK-type order conditions that must be satisfied by 4 -stage $\mathrm{HB}(p)$ methods.

First, we need to satisfy the following set of multistep-type consistency conditions:

Second, to reduce a large number of RK-type order conditions (see [20]), we impose the following simplifying assumptions:

Thus, there remain only two sets of equations to be solved:

where the backstep parts, $B(j)$, are defined by

These order conditions are simply RK order conditions with backstep parts $B_{i}(\cdot)$ and $B(\cdot)$.

## 4. Vandermonde-type formulation of particular variable step $\operatorname{HB}(p)$

The general $\mathrm{HB}(p)$ methods obtained in Section 3 contain free coefficients: $c_{i}$, $i=2,3,4$, coefficients in (5), and depend on $h_{n+1}$ and the previous nodes, $t_{n}, t_{n-1}, \ldots, t_{n-(p-3)}$, which determine $\eta_{2}, \eta_{3}, \ldots, \eta_{p-2}$ in (7). For simplicity and to obtain large regions of absolute stability, $\mathcal{R}$, of particular variable-step $\mathrm{HB}(p)$ methods, the coefficients listed in (14) and Table 1 were chosen and, following the approach of Butcher and Chen [4], the following condition is imposed on the coefficients:

The remaining of this paper is concerned with particular $\operatorname{VS} \operatorname{HB}(9)$ and $\mathrm{HB}(10)$ with coefficients $c_{i}, i=1,2, \ldots, 5$ given by

### 4.1. Integration formula IF

The $(p+1)$-vector of reordered coefficients of the integration formula IF in (3),

### 4.2. Predictor $\mathrm{P}_{2}$

The ( $p-1$ )-vector of reordered coefficients of the predictor $\mathrm{P}_{2}$ in (2) with $i=2$,

### 4.3. Predictor $\mathrm{P}_{3}$

We consider the $(p+1)$-vector of coefficients of the predictor $\mathrm{P}_{3}$ in (2) with $i=3$,

We consider the $(p+2)$-vector of the coefficients of predictor $\mathrm{P}_{5}$ in (4),

For arbitrary nonzero $\omega_{4}$ and $\omega_{2}, \mathrm{P}_{5}$ yields $\widetilde{y}_{n+1}$ to order $(p-2)$. A good experimental choice is $\omega_{5}=0.025, \omega_{4}=0.025$ and $\omega_{2}=-10^{-12}$.

The solutions $\boldsymbol{u}^{\ell}, \ell=1,2, \ldots, 5$, form generalized Lagrange basis functions for representing the HB interpolation polynomials.

## 5. SYMBOLIC CONSTRUCTION OF ELEMENTARY MATRIX FUNCTIONS

Consider the matrices

$$
\begin{equation*}
M^{\ell} \in \mathbb{R}^{m_{\ell} \times m_{\ell}}, \quad \ell=1,2,4,5 \tag{26}
\end{equation*}
$$

of the Vandermonde-type systems (15), (17), (20) and (24), where

m_{1}=p+1, \quad m_{2}=p-1, \quad m_{4}=p+1, \quad m_{5}=p-1 \tag{27}
\end{equation*}
$$

and $p$ is the order of the method.
The purpose of this section is to construct elementary lower and upper triangular matrices as symbolic functions of the parameters of $\mathrm{HB}(p)$. These matrices are most easily constructed by means of a symbolic software. These functions will be used in Section 6 to factor

- $M^{1}$ into a diagonal+last-three-column matrix, $W_{3}^{1}$, which will be further diagonalized by a Gaussian elimination,
- $M^{2}$ into the identity matrix,
- $M^{4}$ into a diagonal+last-row+last-two-column matrix $W_{3}^{4}$, which will be further diagonalized by a Gaussian elimination,
- $M^{5}$ into a diagonal+last-column matrix $W_{1}^{5}$ which will be further diagonalized by a Gaussian elimination.

This decomposition will lead to a fast solution of the systems $M^{\ell} \boldsymbol{u}^{\ell}=\boldsymbol{r}^{\ell}, \ell=1,2,4,5$ in $\mathrm{O}\left(p^{2}\right)$ operations.

Since the Vandermonde-type matrices $M^{\ell}$ can be decomposed into the product of a diagonal matrix containing reciprocals of factorials and a confluent Vandermonde matrix, the factorizations used in this paper hold following the approach of Björck and Pereyra [3], Krogh [18], Galimberti and Pereyra [12] and Björck and Elfving [2]. Pivoting is not needed in this decomposition because of the special structure of Vandermonde-type matrices.

### 5.1. Symbolic construction of lower bidiagonal matrices for $M^{\ell}, \ell=$

 $1,2,4,5$5.1.1. Symbolic construction of lower bidiagonal matrices for $M^{\ell}, \ell=1,5$

We first describe the zeroing process of a general vector $\boldsymbol{x}=\left[x_{1}, x_{2}, \ldots, x_{m}\right]^{T}$ with no zero elements. The lower bidiagonal matrix

zeros the last ( $m-k$ ) components, $x_{k+1}, x_{k+2}, \ldots, x_{m}$, of $\boldsymbol{x}$. This zeroing process will be applied recursively on $M^{\ell}, \ell=1,5$, as follows. For $k=2,3, \ldots$, left multiplying $T_{k}^{\ell}=L_{k-1}^{\ell} L_{k-2}^{\ell} \cdots L_{3}^{\ell} L_{2}^{\ell} M^{\ell}$ by $L_{k}^{\ell}$ zeros the last ( $m_{\ell}-k$ ) components of the $k$ th column of $T_{k}^{\ell}$. Thus we obtain the upper triangular matrix

in $\left(m_{1}-4\right)$ and $\left(m_{5}-2\right)$ steps respectively.
We note that $L^{\ell}$ does not change the first two rows of $M^{\ell}$.
Process 1. At the $k$ th step, starting with $k=2$,

- $M^{\ell(k-1)}=L_{k-1}^{\ell} L_{k-2}^{\ell} \cdots L_{2}^{\ell} M^{\ell}$ is an upper triangular matrix in columns 1 to $k-1$.
- The multipliers in $L_{k}^{\ell}$ are obtained from $M^{\ell(k-1)}\left(k+1: m_{\ell}, k\right)$ since $M^{\ell}(i, k) \neq$ 0 for $i=k+1, k+2, \ldots, m_{\ell}$.

Algorithm 1 in Appendix A describes this process.
With $\ell=1$, the input is $M=M^{1} ; m=m_{1}$. The output is $L_{k}=L_{k}^{1}, k=$ $2,3, \ldots, m_{1}-3$.

With $\ell=5$, the input is $M=M^{5} ; m=m_{5}$. The output is $L_{k}=L_{k}^{5}, k=$ $2,3, \ldots, m_{5}-1$.

### 5.1.2. Symbolic construction of lower bidiagonal matrices for $M^{2}$

The zeroing process by means of lower bidiagonal matrix (28) defined by the multipliers (29) will be applied recursively on $M^{2}$, as follows. For $k=3,4, \ldots, m_{2}-1$, left multiplying $T_{k}^{2}=L_{k-1}^{2} L_{k-2}^{2} \cdots L_{4}^{2} L_{3}^{2} M^{2}$ by $L_{k}^{2}$ zeros the last $\left(m_{2}-k\right)$ components of the $k$ th column of $T_{k}^{2}$. Thus we obtain the upper triangular matrix

in $\left(m_{2}-3\right)$ steps respectively.
We note that $L^{2}$ does not change the first three rows of $M^{2}$.
Process 2. At the $k$ th step, starting with $k=3$,

- $M^{2(k-1)}=L_{k-1}^{2} L_{k-2}^{2} \cdots L_{3}^{2} M^{2}$ is an upper triangular matrix in columns 1 to $k-1$.
- The multipliers in $L_{k}^{2}$ are obtained from $M^{2(k-1)}\left(k+1: m_{2}, k\right)$ since $M^{2}(i, k) \neq$ 0 for $i=k+1, k+2, \ldots, m_{2}$.

Algorithm 1 in Appendix A describes this process.
The input is $M=M^{2} ; m=m_{2}$. The output is $L_{k}=L_{k}^{2}, k=3,4, \ldots, m_{2}-1$.

### 5.1.3. Symbolic construction of lower bidiagonal matrices for $M^{4}$

We first describe the zeroing process of a general vector $\boldsymbol{x}=\left[x_{1}, x_{2}, \ldots, x_{m-1}, 0\right]^{T}$ whose first $(m-1)$ components are non zero elements. The lower bidiagonal matrix

0 & 0 & 0 & 0 & 0 & 1
\end{array}\right],

defined by the multipliers

zeros the last $(m-1-k)$ components, $x_{k+1}, x_{k+2}, \ldots, x_{m-1}$, of $\boldsymbol{x}$. This zeroing process will be applied recursively on $M^{4}$ as follows. For $k=3,4, \ldots, m_{4}-2$, left multiplying $T_{k}^{4}=L_{k-1}^{4} \cdots L_{4}^{4} L_{3}^{4} M^{4}$ by $L_{k}^{4}$ zeros the last ( $m_{4}-1-k$ ) components of the $k$ th column of $T_{k}^{4}$. Thus we obtain the upper triangular matrix in row 1 to $m_{4}-1$ and in column 1 to $m_{4}-2$,

We note that $L^{4}$ does not change the first three rows and the last row of $M^{4}$.
Process 3. At the $k$ th step, starting with $k=3$,

- $M^{4(k-1)}=L_{k-1}^{4} L_{k-2}^{4} \cdots L_{3}^{4} M^{4}$ is an upper triangular matrix in row 1 to $m_{4}-1$ and in columns 1 to $k-1$.

- The multipliers in $L_{k}^{4}$ are obtained from $M^{4(k-1)}\left(k+1: m_{4}-1, k\right)$ since $M^{4}(i, k) \neq 0$ for $i=k+1, k+2, \ldots, m_{4}-1$.
Algorithm 1 in Appendix A describes this process.
The input is $M=M^{4} ; m=m_{4}$. The output is $L_{k}=L_{k}^{4}, k=3,4, \ldots, m_{4}-2$.


### 5.2. Symbolic construction of elementary upper triangular matrices

### 5.2.1. Symbolic construction of upper bidiagonal matrices for $M^{1}$

For matrix $L^{1} M^{1}$, we construct recursively upper bidiagonal matrices $U_{1}^{1}, U_{2}^{1} \ldots, U_{m_{1}-4}^{1}$ such that right multiplying $L^{1} M^{1}$ by the upper triangular matrix $U^{1}=U_{1}^{1} U_{2}^{1} \cdots U_{m_{1}-4}^{1}$ transforms $L^{1} M^{1}$ into a matrix $W_{3}^{1}=L^{1} M^{1} U^{1}$ with nonzero diagonal elements, $W_{3}^{1}(i, i) \neq 0, i=1,2, \ldots, m_{1}$, the last three nonzero columns $W_{3}^{1}\left(1: m_{1}, j\right) \neq 0$, $j=m_{1}-2, m_{1}-1, m_{1}$, and zero elsewhere. We call such a matrix a "diagonal+last-three-column matrix" matrix.

We describe the zeroing process of the upper bidiagonal matrix $U_{k}^{1}$ on the tworow matrix $\left(L^{1} M^{1}\right)\left(k: k+1,1: m_{1}\right)$ :

The divisors

define the upper bidiagonal matrix

I_{k-1} & 0 & \cdots & 0 & \cdots & 0 & 0 & 0 & 0  \tag{38}\\
0 & 1 & -\sigma_{k+1} & 0 & \cdots & 0 & 0 & 0 & 0 \\
0 & 0 & \sigma_{k+1} & -\sigma_{k+2} & \cdots & 0 & 0 & 0 & 0 \\
\vdots & \vdots & & \ddots & \ddots & & & & \vdots \\
0 & 0 & 0 & \cdots & \sigma_{m_{1}-4} & -\sigma_{m_{1}-3} & 0 & 0 & 0 \\
0 & 0 & 0 & \cdots & 0 & \sigma_{m_{1}-3} & 0 & 0 & 0 \\
0 & 0 & 0 & \cdots & 0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & \cdots & 0 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & \cdots & 0 & 0 & 0 & 0 & 1

Right multiplying (36) by $U_{k}^{1}$ zeros the 1's in position $k+1, k+2, \ldots, m_{1}-3$ in the first row and puts 1 's in position $k+1, k+2, \ldots, m_{1}-3$ in the second row:

Thus, $U^{1}=U_{1}^{1} U_{2}^{1} \cdots U_{m_{1}-4}^{1}$ transforms the upper triangular matrix $L^{1} M^{1}$ into the diagonal+last-three-column matrix

in $\left(m_{1}-4\right)$ steps.
Process 4. At the $k$ th step, starting with $k=1$,

- $M^{1(k)}=L^{1} M^{1} U_{1}^{1} U_{2}^{1} \cdots U_{k}^{1}$ is a diagonal+last-three-column matrix in rows 1 to $k$.
- The divisors in $U_{k}^{1}$ are obtained from $M^{1(k-1)}\left(k+1, k: m_{1}-3\right)$ since $M^{1(k-1)}(k+$ $1, j)-M^{1(k-1)}(k+1, j-1) \neq 0, j=k+1, k+2, \ldots, m_{1}-3$.
Algorithm 2 in Appendix A describes this process for $M^{1}$. The input is $M=M^{1}$; $m=m_{1}$. The output is $U_{k}=U_{k}^{1}, k=1,2, \ldots, m_{1}-4$.

The next two subsections, Subsection 5.2.2 and Subsection 5.2.3 describe the construction of elementary upper triangular matrices $U_{k}^{2}, k=1,2, \ldots, m_{2}-1$ for $M^{2}$.

### 5.2.2. Construction of initializing upper tridiagonal matrix $U_{1}^{2}$ for $M^{2}$

For matrix $L^{2} M^{2}$, first, we construct the initializing upper tridiagonal matrix $U_{1}^{2}$ such that right multiplying $L^{2} M^{2}$ by $U_{1}^{2}$ transforms $L^{2} M^{2}$ into a matrix whose first two rows are of the form:

Right multiplying (42) by $U_{1}^{2}$ zeros the 1's in position $3,4, \ldots, m_{2}$ in the first row and puts 1's in position $3,4, \ldots, m_{2}$ in the second row: the resulting $\left(L^{2} M^{2}\right)(1$ : $\left.2,1: m_{2}\right) U_{1}^{2}$ is of the form (41).

### 5.2.3. Symbolic construction of upper bidiagonal matrices for $M^{2}$

For matrix $L^{2} M^{2}$, we construct recursively upper bidiagonal matrices $U_{2}^{2}, U_{3}^{2}, \ldots, U_{m_{2}-1}^{2}$ such that right multiplying $L^{2} M^{2}$ by the upper triangular matrix $U^{2}=U_{1}^{2} U_{2}^{2} \cdots U_{m_{2}-1}^{2}$ transforms $L^{2} M^{2}$ into the identity matrix $I^{2}=L^{2} M^{2} U^{2}$.

We describe the zeroing process of the upper bidiagonal matrix $U_{k}^{2}$ on the tworow matrix $\left(L^{2} M^{2}\right)\left(k: k+1,1: m_{2}\right)$ :

0 & 0 & 0 & \cdots & \sigma_{m_{2}-1} & -\sigma_{m_{2}} \\
0 & 0 & 0 & \cdots & 0 & \sigma_{m_{2}}
\end{array}\right] .

Right multiplying (45) by $U_{k}^{2}$ zeros the 1's in position $k+1, k+2, \ldots, m_{2}$ in the first row and puts 1 's in position $k+1, k+2, \ldots, m_{2}$ in the second row:

Thus, right multiplying $L^{2} M^{2}$ by the upper triangular matrix $U^{2}=U_{1}^{2} U_{2}^{2} \cdots U_{m_{2}-1}^{2}$ transforms the upper triangular matrix $L^{2} M^{2}$ into the identity matrix

- $M^{2(k)}=L^{2} M^{2} U_{1}^{2} U_{2}^{2} \cdots U_{k}^{2}$ is the identity matrix in rows 1 to $k$.
- The divisors in $U_{k}^{2}$ are obtained from $M^{2(k-1)}\left(k+1, k: m_{2}\right)$ since $M^{2(k-1)}(k+$ $1, j)-M^{2(k-1)}(k+1, j-1) \neq 0, j=k+1, k+2, \ldots, m_{2}$.
Algorithm 3 in Appendix A describes this process for $M^{2}$. The input is $M=M^{2}$; $m=m_{2}$. The output is $U_{k}=U_{k}^{2}, k=1,2, \ldots, m_{2}-1$.

The next two subsections, Subsection 5.2.4 and Subsection 5.2.5 describe the construction of elementary upper triangular matrices $U_{k}^{4}, k=1,2, \ldots, m_{4}-3$ for $M^{4}$.

### 5.2.4. Construction of initializing upper tridiagonal matrix $U_{1}^{4}$ for $M^{4}$

For matrix $L^{4} M^{4}$, first, we construct the initializing upper tridiagonal matrix $U_{1}^{4}$ such that right multiplying $L^{4} M^{4}$ by $U_{1}^{4}$ transforms $L^{4} M^{4}$ into a matrix whose first two rows are of the form:

define the elementary upper tridiagonal matrix $U_{1}^{4}$ of the form

Right multiplying (51) by $U_{1}^{4}$ zeros the 1 's in position $3,4, \ldots, m_{4}-2$ in the first row and puts 1 's in position $3,4, \ldots, m_{4}-2$ in the second row: the resulting $\left(L^{4} M^{4}\right)\left(1: 2,1: m_{4}\right) U_{1}^{4}$ is of the form (50).

### 5.2.5. Symbolic construction of elementary upper bidiagonal matrices for $M^{4}$

For matrix $L^{4} M^{4}$, we construct recursively upper bidiagonal matrices $U_{2}^{4}, U_{3}^{4}, \ldots, U_{m_{4}-3}^{4}$ such that right multiplying $L^{4} M^{4}$ by the upper triangular matrix $U^{4}=U_{1}^{4} U_{2}^{4} \cdots U_{m_{4}-3}^{4}$ transforms $L^{4} M^{4}$ into a matrix $W_{3}^{4}=L^{4} M^{4} U^{4}$ with nonzero diagonal elements, $W_{3}^{4}(i, i) \neq 0, i=1,2, \ldots, m_{4}$, the last nonzero row $W_{3}^{4}\left(m_{4}, j\right), j=1,2, \ldots, m_{4}-1$, the last two nonzero columns $W_{3}^{4}\left(1: m_{4}, j\right) \neq 0, j=m_{4}-1, m_{4}$, and zero elsewhere. We call such a matrix a "diagonal+last-row+last-two-column" matrix. Here the last nonzero row $W_{3}^{4}\left(m_{4}, j\right), j=1,2, \ldots, m_{4}$ contains some nonzero entries and zero elsewhere.

We describe the zeroing process of the upper bidiagonal matrix $U_{k}^{4}$ on the tworow matrix $\left(L^{4} M^{4}\right)\left(k: k+1,1: m_{4}\right)$ :

- $M^{4(k)}=L^{4} M^{4} U_{1}^{4} U_{2}^{4} \cdots U_{k}^{4}$ is a diagonal+last-row+last-two-column matrix in rows 1 to $k$.
- The divisors in $U_{k}^{4}$ are obtained from $M^{4(k-1)}\left(k+1, k: m_{4}-2\right)$ since $M^{4(k-1)}(k+$ $1, j)-M^{4(k-1)}(k+1, j-1) \neq 0, j=k+1, k+2, \ldots, m_{4}-2$.
Algorithm 3 in Appendix A describes this process for $M^{4}$. The input is $M=M^{4}$; $m=m_{4}$. The output is $U_{k}=U_{k}^{4}, k=1,2, \ldots, m_{4}-3$.


### 5.2.6. Symbolic construction of upper bidiagonal matrices for $M^{5}$

For matrix $L^{5} M^{5}$, we construct recursively upper bidiagonal matrices $U_{1}^{5}, U_{2}^{5} \ldots, U_{m_{5}-2}^{5}$ such that right multiplying $L^{5} M^{5}$ by the upper triangular matrix $U^{5}=U_{1}^{5} U_{2}^{5} \cdots U_{m_{5}-2}^{5}$ transforms $L^{5} M^{5}$ into a matrix $W_{1}^{5}=L^{5} M^{5} U^{5}$ with nonzero diagonal elements, $W_{1}^{5}(i, i) \neq 0, i=1,2, \ldots, m_{5}$, nonzero $W_{1}^{5}\left(1: m_{5}, m_{5}\right) \neq 0$, in the last column, and zero elsewhere. We call such a matrix a "diagonal+last-column" matrix. We describe the zeroing process of the upper bidiagonal matrix $U_{k}^{5}$ on the two-row matrix $\left(L^{5} M^{5}\right)\left(k: k+1,1: m_{5}\right):$

\end{equation*}
$$

define the upper bidiagonal matrix

I_{k-1} & 0 & \cdots & 0 & \cdots & 0 & 0 & 0  \tag{61}\\
0 & 1 & -\sigma_{k+1} & 0 & \cdots & 0 & 0 & 0 \\
0 & 0 & \sigma_{k+1} & -\sigma_{k+2} & \cdots & 0 & 0 & 0 \\
\vdots & \vdots & & \ddots & \ddots & & \vdots & \vdots \\
0 & 0 & 0 & \cdots & \sigma_{m_{5}-3} & -\sigma_{m_{5}-2} & 0 & 0 \\
0 & 0 & 0 & \cdots & 0 & \sigma_{m_{5}-2} & -\sigma_{m_{5}-1} & 0 \\
0 & 0 & 0 & \cdots & 0 & 0 & \sigma_{m_{5}-1} & 0 \\

- $M^{5(k)}=\left(L^{5} M^{5}\right) U_{1}^{5} U_{2}^{5} \cdots U_{k}^{5}$ is a diagonal+last-column matrix in rows 1 to $k$.
- The divisors in $U_{k}^{5}$ are obtained from $M^{5(k-1)}\left(k+1, k: m_{5}-1\right)$ since $M^{5(k-1)}(k+$ $1, j)-M^{5(k-1)}(k+1, j-1) \neq 0, j=k+1, k+2, \ldots, m_{5}-1$.

Algorithm 2 in Appendix A describes this process. The input is $M=M^{5} ; m=m_{5}$. The output is $U_{k}=U_{k}^{5}, k=1,2, \ldots, m_{5}-2$.

## 6. Fast solution of Vandermonde-type systems for particular $\operatorname{HB}(p)$

Symbolic elementary matrix functions $L_{k}^{\ell}$ and $U_{k}^{\ell}, \ell=1,2,4,5$, are constructed once as functions of $\eta_{j}$, for $j=2,3, \ldots, p-2$ by Algorithms 1,2 and 3 in Appendix A:

- Algorithms 1 and 2 to factor $M^{1}$ into a diagonal+last-three-column matrix, $W_{3}^{1}$, which will be further diagonalized by a Gaussian elimination,
- Algorithms 1 and 3 to factor $M^{2}$ into the identity matrix,
- Algorithms 1 and 3 to factor $M^{4}$ into a diagonal+last-row+last-two-column matrix, $W_{3}^{4}$, which will be further diagonalized by a Gaussian elimination,
- Algorithms 1 and 2 to factor $M^{5}$ into a diagonal+last-column matrix, $W_{1}^{5}$, which will be further diagonalized by a Gaussian elimination.
These elementary matrix functions are used, first, to find the solution $\boldsymbol{u}^{\ell}, \ell=1,2,4,5$ in elementary matrix functions form and, then, to construct fast Algorithms 4, 5, 6 and 7 , in Appendix A, to solve systems (15), (17), (20) and (24) at each integration step.


### 6.1. Solution of $M^{1} \boldsymbol{u}^{1}=\boldsymbol{r}^{1}$

We let $m_{1}=p+1$ as defined in (27).
(1) The elimination procedure of Subsection 5.1.1 is applied to $M^{1}$ to construct $m_{1} \times m_{1}$ lower bidiagonal matrices $L_{k}^{1}, k=2,3, \ldots, m_{1}-3$, with multipliers

Left multiplying the coefficient matrix $M^{1}$ by the lower triangular matrix $L^{1}=L_{m_{1}-3}^{1} \cdots L_{3}^{1} L_{2}^{1}$ transforms $M^{1}$ into the upper triangular matrix $L^{1} M^{1}$ in column 1 to $m_{1}-3$ of the form (30).
(2) The elimination procedure of Subsection 5.2 .1 is used to construct $m_{1} \times m_{1}$ upper bidiagonal matrices $U_{k}^{1}, k=1,2, \ldots, m_{1}-4$, with multipliers

(3) A factored Gaussian elimination, $L_{m_{1}-1}^{1} L_{m_{1}-2}^{1}$, will transform $W_{3}^{1}$ into a diagonal+last-two-column matrix $W_{2}^{1}=L_{m_{1}-1}^{1} L_{m_{1}-2}^{1} W_{3}^{1}$ as follows. First, $W_{3}^{1}\left(m_{1}-2, m_{1}-2\right)$ is set to 1 by the diagonal matrix $L_{m_{1}-2}^{1}$ whose entries are zeros, except for,

Then the non-diagonal entries in the column $m_{1}-2$ of $L_{m_{1}-2}^{1} W_{3}^{1}$ are zeroed by the unit diagonal+column- $\left(m_{1}-2\right)$ matrix $L_{m_{1}-1}^{1}$ whose entries are zeros, except for,

(4) A factored Gaussian elimination, $L_{m_{1}+1}^{1} L_{m_{1}}^{1}$, will transform $W_{2}^{1}$ into a diagonal+lastcolumn matrix $W_{1}^{1}=L_{m_{1}+1}^{1} L_{m_{1}}^{1} W_{2}^{1}$ as follows. First, $W_{2}^{1}\left(m_{1}-1, m_{1}-1\right)$ is set to 1 by the diagonal matrix $L_{m_{1}}^{1}$ whose entries are zeros, except for,

for,

(5) A factored Gaussian elimination, $L_{m_{1}+3}^{1} L_{m_{1}+2}^{1}$, will transform $W_{1}^{1}$ into the identity matrix $I^{1}=L_{m_{1}+3}^{1} L_{m_{1}+2}^{1} W_{1}^{1}$ as follows. First, $W_{1}^{1}\left(m_{1}, m_{1}\right)$ is set to 1 by the diagonal matrix $L_{m_{1}+2}^{1}$ whose entries are zeros, except for,

The input is $M=M^{1} ; m=m_{1} ; \boldsymbol{r}=\boldsymbol{r}^{1} ; L_{k}=L_{k}^{1}, k=2,3, \ldots, m_{1}+3$; $U_{k}=U_{k}^{1}, k=1,2, \ldots, m_{1}-4$. The output is $\boldsymbol{u}=\boldsymbol{u}^{1}$.

It is to be noted that, by using Algorithm 2, the new $\sigma_{i}=\frac{k}{M^{1}(2, i)-M^{1}(2, i-k)}=$ $U_{k}^{1}(i, i)$ in (65) is found for integration formula IF instead of $\sigma_{i}=\frac{1}{M^{1}(2, i)-M^{1}(2, i-k)}=$ $U_{k}^{1}(i, i)$ of the usual Newton divided differences. Similar result is found for predictor $\mathrm{P}_{i}, i=2,3,4$.

(2) The elimination procedure of Subsection 5.2.6 is used to construct $m_{5} \times m_{5}$ upper bidiagonal matrices $U_{k}^{5}, k=1,2, \ldots, m_{5}-2$, with multipliers

The output is $\boldsymbol{u}=\boldsymbol{u}^{5}$.

Remark 1. Formulae (2)-(4) can be put in matrix form. For instance, (3) can be written as

The first form is used in this paper, the form similar to the second form for Vandermonde systems is found in [18], and the third form is found in [21].

## 7. Regions of absolute stability

The regions of absolute stability, $\mathcal{R}$, of constant step $\operatorname{HB}(p), p=4,5, \ldots, 10$, listed in Appendix B, with coefficients $c_{i}, i=1,2, \ldots, 5$ given by (14), can be obtained by applying formulae (2)-(3) of the predictors $\mathrm{P}_{i}, i=2,3,4$ and the integration formula IF with constant $h$ to the linear test equation

This gives the following difference equation and corresponding characteristic equation

respectively, where $k=p-2$ is the number of steps of the method and $z=\lambda h$. A complex number $z$ is in $\mathcal{R}$ if the $k$ roots of the characteristic equation in (79) satisfy the root condition (see [19, pp. 70]). The scanning method used to find $\mathcal{R}$ is similar to the one used for Runge-Kutta methods (see [19]).

The stability functions $\eta_{j}(z), j=0,1, \ldots, k$ in (79) are rational functions of the form

\eta_{k}(z)=1, \quad \eta_{j}(z)=\frac{\sum_{\ell=0}^{3} n_{j \ell} z^{\ell}}{\sum_{\ell=0}^{4} d_{j \ell} z^{\ell}}, \quad j=0,1, \ldots, k-1 .
$$

Here $\eta_{k-1}(z)$ is of this form since the condition (13) is satisfied. Hence, in the difference equation of (79), $y_{n+k} \rightarrow 0$ as $z \rightarrow \infty$. This implies that $\operatorname{HB}(p), p=$ $4,5, \ldots, 10$ are $L$-stable or $L(\alpha)$-stable according to whether these methods are $A$ stable or $A(\alpha)$-stable, respectively.

Table 2 lists the $\alpha$ angles of $A(\alpha)$-stability of $\operatorname{HB}(4-10), \operatorname{MEBDF}(2-9)[14$, p. 270] and $\operatorname{BDF}(1-6)$ [14, p. 251], respectively. It is seen that $\alpha$ of $\operatorname{HB}(p), p=4,5, \ldots, 10$ compare favorably with $\alpha$ of $\operatorname{MEBDF}(p), p=3,4, \ldots, 9$ which decrease faster than $\alpha$ of $\operatorname{HB}(p)$ for $p \geq 7$.

## 8. Controlling stepsize

The estimate $\left\|y_{n}-\widetilde{y}_{n}\right\|_{\infty}$ and the current step $h_{n}$ are used to calculate the next stepsize $h_{n+1}$ by means of formula [17]

$$
\begin{equation*}
h_{n+1}=\min \left\{h_{\max }, \beta h_{n}\left[\frac{\text { tolerance }}{\left\|y_{n}-\widetilde{y}_{n}\right\|_{\infty}}\right]^{1 / \kappa}, 4 h_{n}\right\} \tag{80}
\end{equation*}
$$

with $\kappa=p-1$ and safety factor $\beta=0.81$.
The procedure to advance integration from $t_{n}$ to $t_{n+1}$ is as follows.
(a) The stepsize, $h_{n+1}$, is obtained by formula (80) with $\kappa=p-1$.
(b) The numbers $\eta_{2}, \eta_{3}, \ldots, \eta_{p-2}$, defined in (7), are calculated.
(c) The coefficients of integration formula IF, predictors $\mathrm{P}_{2}, \mathrm{P}_{3}, \mathrm{P}_{4}$ and step control predictor $\mathrm{P}_{5}$ are obtained successively as solutions of systems (15), (17), (19), (20) and (24).
(d) The values $Y_{2}, Y_{3}, Y_{4}, y_{n+1}$, and $\widetilde{y}_{n+1}$ are obtained by formulae (2)-(4).
(e) The step is accepted if $\left\|y_{n+1}-\widetilde{y}_{n+1}\right\|_{\infty}$ is smaller than the chosen tolerance and the program goes to (a) with $n$ replaced by $n+1$. Otherwise the program returns to (a) and a new smaller stepsize $h_{n+1}$ is computed.

## 9. Numerical results

The error at the endpoint of the integration interval EPE, endpoint error, is taken in the uniform norm,

$$
\mathrm{EPE}=\left\{\left\|y_{\mathrm{end}}-z_{\mathrm{end}}\right\|_{\infty}\right\}
$$

where $y_{\text {end }}$ is the numerical value obtained by the numerical method at the endpoint $t_{\text {end }}$ of the integration interval and $z_{\text {end }}$ is the "exact solution" obtained by MATLAB's ode15s with stringent tolerance $5 \times 10^{-14}$.

The necessary starting values at $t_{1}, t_{2}, \ldots, t_{k-1}$ for $\operatorname{HB}(p)$ were obtained by MATLAB's ode15s with stringent tolerance $5 \times 10^{-14}$.

We consider four following test problems:
(1) The Robertson chemical reaction [23, pp. 178-182].

Problem 1. Robertson chemical reaction:

(2) The stiff DETEST problem D1 [10].

with $t_{\text {end }}=400$.
(3) The Oregonator equation describing Belusov-Zhabotinskii reaction [11].

Problem 3. The Oregonator model describing Belusov-Zhabotinskii reaction

(4) The van der Pol's equation [14, pp. 4-6], [16].

where $\mu=500$ and with $t_{\text {end }}=0.8$.
Similar to Hojjati et al. [16], we numerically compare our new methods with $\operatorname{MEBDF}(p), p=7,8$, on the basis of the EPE, endpoint error as a function of number of steps (NS).

Table 3, 4, 5 and 6 list endpoint errors (EPEs) as a function of number of steps (NS) of $\operatorname{HB}(p), p=9,10$ and $\operatorname{MEBDF}(p), p=7,8$ for Robertson chemical reaction problem (81), stiff problem D1 (82), Oregonator problem (83) and van der Pol's equation (84), respectively.

It is seen that, in general, $\operatorname{HB}(p), p=9,10$, compare favorably with $\operatorname{MEBDF}(p)$, $p=7,8$, at stringent tolerance.

The NS percentage efficiency gain (NS PEG) is defined by the formula (cf. Sharp [24]),

where $\mathrm{NS}_{1, j}$ and $\mathrm{NS}_{2, j}$ are the NS of methods 1 and 2 , respectively, and $j=$ $-\log _{10}$ (EPE). To compute $\mathrm{NS}_{2, j}$ and $\mathrm{NS}_{1, j}$ appearing in (85), we approximate the data $\left(\log _{10}(\mathrm{EPE}), \log _{10}(\mathrm{NS})\right)$ in a least-squares sense by MATLAB's polyfit. Then, for chosen integer values of the summation index $j$, we take $-\log _{10}(\mathrm{EPE})=j$ and obtain $\log _{10}(\mathrm{NS})$ from the approximating curve, and finally NS PEG.

Table 7 lists the NS PEG of $\operatorname{HB}(p), p=9,10$, over $\operatorname{MEBDF}(p), p=7,8$, for four problems. It is seen that $\operatorname{HB}(p), p=9,10$, win.

As an example, for van der Pol's equation, $\operatorname{HB}(p), p=9,10$ take 159 steps, compared to 576 steps used by $\operatorname{MEBDF}(p), p=7,8$ to obtain an EPE of $7.0 \mathrm{e}-10$, approximatively.

## 10. Conclusion

Variable-step (VS) 4-stage $k$-step Hermite-Birkhoff (HB) methods of order $p=$ $(k+2), p=9,10$, denoted by $\mathrm{HB}(p)$, are constructed as a combination of linear $k$-step methods of order ( $p-2$ ) and a diagonally implicit one-step 4 -stage RungeKutta method of order 3 (DIRK3) for solving stiff ordinary differential equations. Forcing a Taylor expansion of the numerical solution to agree with an expansion of the true solution leads to multistep and Runge-Kutta type order conditions which are reorganized into linear confluent Vandermonde-type systems. This approach allows us to develop $L(\alpha)$-stable methods of order up to 10 . Fast algorithms are developed for solving these systems in $\mathrm{O}\left(p^{2}\right)$ operations to obtain HB interpolation polynomials in terms of generalized Lagrange basis functions. The stepsizes of these methods are controlled by a local error estimator. $\mathrm{HB}(p)$ of order $p=9$ and 10 compare favorably with existing Cash modified extended backward differentiation formulae of order 7 and $8, \operatorname{MEBDF}(7-8)$, in solving problems often used to test higher order stiff ODE solvers on the basis of number of steps and error at the endpoint of the integration interval.

Definition 1. Algorithm 1 constructs $L_{k}(i, i-1)$ entries of lower bidiagonal matrices $L_{k}$ (applied to IF, $\boldsymbol{P}_{i}, i=2,4,5$ ) as functions of $\eta_{j}, j=2,3, \ldots, p-2$.

For $k=k_{0}: k_{\text {end }}$, do the following iteration:
For $i=i_{0}:-1: k+1$, do the following two steps:
Step (1) $\quad L_{k}(i, i-1)=-M(i, k) / M(i-1, k)$.
Step (2) For $j=k: m$, compute:

where $k_{0}=2, k_{\text {end }}=m-3, i_{0}=m$ for IF, $k_{0}=3, k_{\text {end }}=m-1, i_{0}=m$ for $\mathrm{P}_{2} k_{0}=3, k_{\text {end }}=$ $m-2, i_{0}=m$ for $\mathrm{P}_{4}$ and $k_{0}=2, k_{\text {end }}=m-1, i_{0}=m$ for $\mathrm{P}_{5}$.
Definition 2. Algorithm 2 constructs diagonal entries $U_{k}(j, j)$ of upper bidiagonal matrices $U_{k}$ (applied to IF and $P_{5}$ ) as functions of $\eta_{j}, j=2,3, \ldots, p-2$.

For $k=1: k_{\text {end }}$, do the following iteration:
For $j=j_{0}:-1: k+1$, do the following two steps:
Step (1) $\quad U_{k}(j, j)=1 /[M(k+1, j)-M(k+1, j-1)]$.
Step (2) for $i=k: j$, compute

M(i, j)=(M(i, j)-M(i, j-1)) U_{k}(j, j),
$$

where $k_{\text {end }}=m-4, j_{0}=m-3$ for IF, and $k_{\text {end }}=m-2, j_{0}=m-1$ for $\mathrm{P}_{5}$.
Definition 3. Algorithm 3 constructs diagonal entries $U_{k}(j, j)$ of upper bidiagonal matrices $U_{k}\left(\right.$ applied to $P_{2}$ and $\left.P_{4}\right)$ as functions of $\eta_{j}, j=2,3, \ldots, p-2$.
(Section 1: for initializing $U_{1}$ )
For $k=1$, do the following iteration:
For $j=j_{0}:-1: 4$, do the following two steps:
Step (1) $\quad U_{k}(j, j)=1 /[M(k+1, j)-M(k+1, j-1)]$.
Step (2) for $i=k: j$, compute

$$
M(i, j)=(M(i, j)-M(i, j-1)) U_{k}(j, j) .
$$

For $j=3$, do the following two steps:
Step (1) $\quad U_{k}(j, j)=1 /[M(k+1, j)-M(k+1, j-2)]$.
Step (2) for $i=k: j$, compute

M(i, j)=(M(i, j)-M(i, j-2)) U_{k}(j, j) .
$$

(Section 2: for $U_{k}, k=2: k_{\text {end }}$ )
For $k=2: k_{\text {end }}$, do the following iteration:
For $j=j_{0}:-1: k+1$, do the following two steps:
Step (1) $\quad U_{k}(j, j)=1 /[M(k+1, j)-M(k+1, j-1)]$.
Step (2) for $i=k: j$, compute

M(i, j)=(M(i, j)-M(i, j-1)) U_{k}(j, j),
$$

where $k_{\text {end }}=m-1, j_{0}=m$ for $\mathrm{P}_{2}$, and $k_{\text {end }}=m-3, j_{0}=m-2$ for $\mathrm{P}_{4}$.
Definition 4. Algorithm 4 solves the systems for IF in $O\left(m^{2}\right)$ operations.
Given $\left[\eta_{2}, \eta_{3}, \ldots, \eta_{p-2}\right]$ and $\boldsymbol{r}=r(1: m)$, the following algorithm overwrites $\boldsymbol{r}$ with the solution $\boldsymbol{u}=u(1: m)$ of the system $M \boldsymbol{u}=\boldsymbol{r}$.
Step (1) The following iteration overwrites $\boldsymbol{r}=r(1: m)$ with $L_{m-3} L_{m-4} \cdots L_{2} \boldsymbol{r}$ : for $k=2,3, \ldots, m-3$, compute

Step (2) This step forms the two matrices $L_{m-2}$ and $L_{m-1}$ : it computes the coefficients $G_{m-2}(i)$, $i=1,2, \ldots, m$ used to form the two matrices $L_{m-2}$ and $L_{m-1}$ which transform $W_{3}^{1}$ into a diagonal+last-two-column matrix $W_{2}^{1}=L_{m-1} L_{m-2} W_{3}^{1}$ :
First set $G_{m-2}(1: m)$,

The following computation overwrites $G_{m-2}(1: m)$ with $L_{m-3} L_{m-4} \cdots L_{2} G_{m-2}(1: m)$ : for $k=2,3, \ldots, m-3$, compute

First set $G_{m-1}(1: m)$,

The following computation overwrites $G_{m-1}(1: m)$ with $L_{m-3} L_{m-4} \cdots L_{2} G_{m-1}(1: m)$ : for $k=2,3, \ldots, m-3$, compute

First set $G_{m}(1: m)$ :

$$

Step (2) This step forms the two matrices $L_{m}$ and $L_{m+1}$ : it computes the coefficients $G_{m}(i), i=$ $1,2, \ldots, m$ used to form the two matrices $L_{m}$ and $L_{m+1}$ which transform $W_{1}^{5}$ into the identity matrix $I^{5}: I^{5}=L_{m+1} L_{m} W_{1}^{5}$.
First set $G_{m}(1: m)$ :

$$
G_{m}(1: m)=M(1: m, m)
$$

The following computation overwrites $G_{m}(1: m)$ with $\quad L_{m-1} L_{m-2} \cdots L_{2} G_{m}(1: m)$ : For $k=2,3, \ldots, m-1$, compute

G_{m}(i)=G_{m}(i)+G_{m}(i-1) L_{k}(i, i-1), \quad i=m, m-1, \ldots, k+1 .
$$

Step (3) The following computation overwrites the newly obtained $\boldsymbol{r}$ with $L_{m+1} L_{m} \boldsymbol{r}$ :

next, for $k=m-1, m-2, \ldots, 1$, compute

Step (4) The following iteration overwrites $\boldsymbol{r}=r(1: m)$ with $U_{1} U_{2} \cdots U_{m-2} \boldsymbol{r}$ :
For $k=m-2, m-3, \ldots, 1$, compute

\begin{aligned}
& r(i)=r(i) U_{k}(i, i), \quad i=k+1, k+2, \ldots, m-1, \\
& r(i)=r(i)-r(i+1), \quad i=k, k+1, \ldots, m-2 .
\end{aligned}
$$
