# On the Solvability of Superlinear and Nonhomogeneous Quasilinear Equations

#### Abstract

Using Mountain Pass Lemma, we obtain the existence of nontrivial weak solutions for a class of superlinear and nonhomogeneous quasilinear equations. The key factor in this paper is to use the new idea of near p-homogeneity in conjunction with variational techniques to obtain a new multiplicity result for a vast set of nonlinear equations, such as the mean curvature equation and so on.

## 1. Introduction

In this paper, we consider the nonlinear elliptic equation

$$
\begin{gather*}
Q u=\lambda|u|^{p-2} u+f(x, u), \quad \text { in } \Omega,  \tag{1.1}\\
u=0, \quad \text { on } \partial \Omega, \\
Q u=\sum_{|\alpha| \leq m}(-1)^{|\alpha|} D^{\alpha} A_{\alpha}\left(x, \xi_{m}(u)\right), \tag{1.2}
\end{gather*}
$$

where $\Omega \subset R^{N}$ is a bounded open connected set, $N \geq 1$. $Q$ is a quasilinear elliptic operator generalizing the p -Laplace, that is, $Q u=-\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)$.

It appears that certain nonlinear mathematical models lead to nonlinear differential equations; one of them describes the behavior compressible fluid in a homogeneous isotropic rigid porous medium, such as the p-Laplace equation. And some purely mathematical properties of the p-Laplace seem to be a challenge for nonlinear analysis, and their study leads to the development of new methods and approaches.

These statements generalize certain homogeneous operators to a class of nonhomogeneous quasilinear elliptic operators. In particular, we get an equation involving the mean curvature [1, page 357], that is, $Q u=\sum_{|\alpha|=1}(-1)^{|\alpha|} D^{\alpha}\left(\left|\xi_{1}^{\prime}(u)\right|^{p-2}+\left(1+\left|\xi_{1}^{\prime}(u)\right|^{2}\right)^{-(2-r) / 2}\right) D^{\alpha} u, r=$ 1 , which is nonhomogeneous; see [2].

For nonhomogeneous quasilinear operators, there are many papers in literature describing the properties of the principle eigenvalue and corresponding principle eigenfunction. One can refer to [3-9]. It is the purpose of this paper to study the existence results of non-homogeneous quasilinear equations. Using Mountain Pass Theorem [10], the work of Leray and Lions (A-3 below) [11], and variational techniques of Euler and Lagrange, we obtain the nontrivial weak solution of (1.1).

In conclusion, we like to say that Theorem 2.1 in this paper extends and unifies the previous results of [2].

This paper is organized as follows. In Section 2, we introduce some preliminaries and state the main results in this paper. In Section 3, the proof of Theorem 2.1 is given.

## 2. Preliminaries and Basic Results

In this section, we introduce the assumptions and definitions necessary for the proof of the theorem to come in the next section.

Let $L^{p}(\Omega)$ denote the usual Lebesgue space endowed with the norm $|u|_{p}^{p}=\int_{\Omega}|u|^{p} d x$, and let $W_{0}^{m, p}(\Omega)$ denote the completion of the space $C_{0}^{\infty}$ in the standard norm $\|u\|_{m, p}=$ $\left(\int_{\Omega} \sum_{|\alpha| \leq m}\left|D^{\alpha} u\right|^{p} d x\right)^{1 / p}$.

Denote by $D^{\alpha}$ the differential operator

where $\alpha=\left(\alpha_{1}, \ldots, \alpha_{N}\right)$ is a multi-index consisting of nonnegative integers, and $|\alpha|=\sum_{i=1}^{N} \alpha_{i}$ denotes the order of $D^{\alpha}$. In order to write nonlinear partial differential operators in a convenient form, we introduce, as in [12], the vector space $R^{S_{m}}$ whose elements are of the form $\xi_{m}(u)(x)=\left\{D^{\alpha}(u(x)):|\alpha| \leq m\right\}$, for each $u \in W_{0}^{m, p}(\Omega)$, where $m$ is a positive integer (note $\left.D^{(0, \ldots, 0)} u=u\right)$.

We will assume that the $Q$ has a variational structure in the sense that there exists a potential function $\Gamma: \Omega \times R^{S_{m}} \rightarrow R$ satisfying the following.
(Q-1) The map $x \rightarrow \Gamma\left(x, \xi_{m}\right)$ is measurable for each $\xi_{m} \in R^{S_{m}}$, and the map $\xi_{m} \rightarrow$ $\Gamma\left(x, \xi_{m}\right)$ is continuously differentiable for a.e. $x \in \Omega$.
(Q-2) There exist constants $p$ and $c_{1}$, with $1<p<\infty$ and $c_{1}>0$, and a nonnegative function $h \in L^{1}(\Omega)$ such that

for a.e. $x \in \Omega$ and all $\xi_{m} \in R^{S_{m}}$.
(Q-3) $\Gamma(x, 0)=0$, a.e. $x \in \Omega$, and for each $\alpha, 0 \leq|\alpha| \leq m,\left(x, \xi_{m}\right) \in \Omega \times R^{S_{m}}$,

The functions $A_{\alpha}: \Omega \times R^{S_{m}} \rightarrow R$ defined in (Q-3) will be assumed to satisfy the Caratheodory conditions (i.e., $A_{\alpha}\left(x, \xi_{m}\right)$, are measurable in $x$ for all $\xi_{m} \in R^{S_{m}}$, and are continuous in $\xi_{m}$ for a.e. $x \in \Omega$ ), as well as the following four conditions.
(A-1) There exists a constant $c_{2}$, with $c_{2}>0$, and a nonnegative function $h_{0} \in L^{p^{\prime}}(\Omega)$, where $p^{\prime}=p /(p-1)$ and $p$ is as in ( $\mathrm{Q}-2$ ), such that

(A-2) There exists a positive constant $c_{0}$ such that

for a.e. $x \in \Omega$ and all $\xi_{m} \in R^{S_{m}}$.
(A-3) Let $\xi_{m}=\left(\eta_{m-1}, \varsigma_{m}\right)$ be the division of $\xi_{m}$ into its $m$ th order component and the corresponding $(m-1)$ st order terms $\eta_{m-1}$, that is, $\eta_{m-1}=\left\{\xi_{\beta}: 0 \leq|\beta| \leq m-1\right\} \in R^{S_{m-1}}$, and $\varsigma_{m}=\left\{\xi_{\alpha}:|\alpha|=m\right\}$. Put $A_{\alpha}\left(x, \xi_{m}\right)=A_{\alpha}\left(x, \eta_{m-1}, \varsigma_{m}\right)$. Then for a.e. $x \in \Omega$ and each $\eta_{m-1} \in R^{S_{m-1}}$, $S_{m} \neq S_{m}^{*}$, we have

(A-4) (Near p-homogeneity). For $0 \leq|\alpha| \leq m$,
(i) $A_{\alpha}\left(x, t \xi_{m}\right) t \xi_{\alpha} \leq|t|^{p} A_{\alpha}\left(x, \xi_{m}\right) \xi_{\alpha},|t| \geq 1$,
(ii) $A_{\alpha}\left(x, t \xi_{m}\right) t \xi_{\alpha} \geq|t|^{p} A_{\alpha}\left(x, \xi_{m}\right) \xi_{\alpha},|t| \leq 1$,
for $t \in R$, a.e. $x \in \Omega$ and all $\xi_{m} \in R^{S_{m}}$.
We note that (A-4)(ii) and the Caratheodory conditions imply that $A_{\alpha}(x, 0)=0$ for $0 \leq|\alpha| \leq m$ and a.e. $x \in \Omega$.

We define the following semilinear Dirichlet form:

From the definition above and (A-2), we get

Then it follows from [13, page 1822] that

Also $f(x, u) \in C(\bar{\Omega} \times R, R)$ will meet the following conditions.
(f-1) There exist constants $b_{0}>0, b_{1}>0$, such that

where $1<r<p<q<p^{*}, p^{*}=N p /(N-m p)$.
(f-2) There exist constants $\theta>p, M>0$, such that

0<F(x, u)=\int_{0}^{u} f(x, s) d s \leq \frac{1}{\theta} u f(x, u), \quad \forall x \in \Omega,|u| \geq M . \tag{2.12}

(f-3) $f(x, 0)=0, u f(x, u) \geq 0, u \in R$ and for a.e. $x \in \Omega, \lim _{t \rightarrow 0}(f(x, t)) /|t|^{p-1}=0$.
Now, we state our main theorem in this paper.
Theorem 2.1. Assume that $Q$ given by (1.2) satisfies ( $Q-1)-(Q-3), A_{\alpha}\left(x, \xi_{m}\right)$ satisfies $(A-1)-(A-4)$, $\lambda \in\left(0, \lambda_{1}\right)$, and $f$ satisfies $(f-1)-(f-3)$. Then problem (1.1) has at least one nontrivial weak solution.

## 3. Proof of the Theorem

Define a functional $I: W_{0}^{m, p}(\Omega) \rightarrow R$ by

Also we note that there are positive constants $c_{3}$ and $c_{4}$ such that

c_{3}\|u\|_{m, p} \leq\left\|\xi_{m}(u)\right\|_{L^{p}} \leq c_{4}\|u\|_{m, p} \quad \forall u \in W_{0}^{m, p}(\Omega), \tag{3.2}

and from the Poincare inequality, there is a positive constant $c_{5}$ such that

Let $W_{0}^{m, p}(\Omega)^{*}$ be the dual of $W_{0}^{m, p}(\Omega) . I^{\prime}(u)$ is the Frechet derivative of $I(u)$. So the weak solutions of problem (1.1) are equivalent to the critical points of $I(u)$. And (f-3) implies that $u=0$ is a trivial solution to problem (1.1).

To derive out Theorem 2.1 we need the following lemma.
Lemma 3.1. Assume that all the conditions in the hypothesis of Theorem 2.1 hold, then I satisfies the (PS) condition.

Proof. (1) We have the boundedness of (PS) sequence of $I(u)$.
Suppose that $\left\{u_{n}\right\}$ is a (PS) sequence of $I(u)$; that is, there exists $C>0$, such that

Let $E=W_{0}^{m, p}(\Omega), S=\left\{u_{n}\right\}$. From (3.4) we obtain

By (Q-2), (A-4) and Fubini theorem, we have

& -\lambda\left(\frac{1}{p}-\frac{1}{\theta}\right) \int_{\Omega}\left|u_{n}\right|^{p} d x+\int_{\Omega}\left(\frac{1}{\theta} u_{n} f\left(x, u_{n}\right)-F\left(x, u_{n}\right)\right) d x \\
\geq & \left(\frac{1}{p}-\frac{1}{\theta}\right)\left(1-\frac{\lambda}{\lambda_{1}}\right) Q\left(u_{n}, u_{n}\right) \\
& +\int_{\Omega\left(\left|u_{n}\right| \geq M\right)}\left(\frac{1}{\theta} u_{n} f\left(x, u_{n}\right)-F\left(x, u_{n}\right)\right) d x  \tag{3.7}\\
& +\int_{\Omega\left(\left|u_{n}\right|<M\right)}\left(\frac{1}{\theta} u_{n} f\left(x, u_{n}\right)-F\left(x, u_{n}\right)\right) d x \\
\geq & \left(\frac{1}{p}-\frac{1}{\theta}\right)\left(1-\frac{\lambda}{\lambda_{1}}\right) Q\left(u_{n}, u_{n}\right)-C_{1} \\
\geq & \left(\frac{1}{p}-\frac{1}{\theta}\right)\left(1-\frac{\lambda}{\lambda_{1}}\right) \frac{c_{0} c_{3}^{p}}{c_{5}}\|u\|_{m, p}^{p}-C_{1}
\end{align*}

where $C_{1}$ is a constant independent of $u_{n}$. The above estimates imply that

Since $W^{m, p}(\Omega)$ is a separable Banach space, from Sobolev compact imbedding theorem [14, page 144] and the weak convergence theorem [15, page 8] we obtain that there exists a subsequence (still denoted by $\left\{u_{n}\right\}$ ) and a function $u \in W_{0}^{m, p}(\Omega)$, such that

(2) Next, for the above $\left\{u_{n}\right\}$ we claim that

Let $\varphi=u_{n}-u$ in (3.5), we see that

We conclude from ( $\mathrm{f}-1$ ) and Sobolev compact imbedding theorem that

where $q^{\prime}=q /(q-1)$.
Also we see from (3.8) that

(3) There exists a subsequence $\left\{u_{n_{k}}\right\}_{k=1}^{\infty} \subset\left\{u_{n}\right\}$ satisfying

To establish (3.17), it is sufficient to establish that subsequence $\left\{u_{n_{k}}\right\}_{k=1}^{\infty}$ satisfies the following two facts.
(c1) One has

(c2) With $\left\{u_{n_{k}}\right\}_{k=1}^{\infty}$ designating the same subsequence as in (3.20),

To see that (c1) and (c2) together imply (3.17), let $\Omega_{1}=\{x \in \Omega,(\mathrm{c} 1)$, (c2), (A-1)-(A-2) hold simultaneously\}. We have meas $\Omega=$ meas $\Omega_{1}$. If (3.17) does not hold, there must exist a point $x_{0} \in \Omega_{1}$, and further a subsequence $\left\{\zeta_{m}\left(u_{n_{k_{l}}}\left(x_{0}\right)\right)\right\}_{l=1}^{\infty}$ and $\zeta_{m}^{*} \in R^{S_{m}-S_{m-1}}$, where $\zeta_{m}^{*} \neq \zeta_{m}\left(u\left(x_{0}\right)\right)$, such that

It is easy to see from (3.20) and (A-3) that the right side of the equality in (3.21) is strictly positive and so the left side. This is contrary with $x_{0} \in \Omega_{1}$ and (c1). Therefore there is no such a point $x_{0}$ in $\Omega_{1}$. Hence (3.17) is established.

Now we need to prove that (c1) and (c2) hold. Set

& p_{k}(x)=\sum_{|\alpha|=m}\left(A_{\alpha}\left(x, \eta_{m-1}\left(u_{n_{k}}\right), \zeta_{m}\left(u_{n_{k}}\right)\right)-A_{\alpha}\left(x, \eta_{m-1}\left(u_{n_{k}}\right), \zeta_{m}(u)\right)\right)  \tag{3.22}\\
& \times\left(D^{\alpha} u_{n_{k}}(x)-D^{\alpha} u(x)\right)=0 .
\end{align*}
$$

From (A-3) we see that $p_{k}(x) \geq 0$, then

$$
\begin{align*}
I_{k}= & \int_{\Omega} p_{k}(x) d x \\
= & -\int_{\Omega_{|\alpha|=m}} \sum_{\alpha}\left(A_{\alpha}\left(x, \eta_{m-1}\left(u_{n_{k}}\right), \zeta_{m}(u)\right)-A_{\alpha}\left(x, \eta_{m-1}(u), \zeta_{m}(u)\right)\right)\left(D^{\alpha} u_{n_{k}}(x)-D^{\alpha} u(x)\right) \\
& \left.-\int_{\Omega_{|\alpha|=m}} A_{\alpha}\left(x, \eta_{m-1}(u), \zeta_{m}(u)\right)\right)\left(D^{\alpha} u_{n_{k}}(x)-D^{\alpha} u(x)\right)  \tag{3.23}\\
& +\int_{\Omega_{|\alpha|=m}} \sum_{=}\left(A_{\alpha}\left(x, \eta_{m-1}\left(u_{n_{k}}\right), \zeta_{m}\left(u_{n_{k}}\right)\right)\right)\left(D^{\alpha} u_{n_{k}}(x)-D^{\alpha} u(x)\right) \\
= & I_{k}^{(1)}+I_{k}^{(2)}+I_{k}^{(3)}
\end{align*}
$$

By [16, page 70], we obtain that $p_{k}(x) \rightarrow 0$, a.e. $x \in \Omega$, if $I_{k} \rightarrow 0$.
From (3.11), (A-1), (A-2) and $u \in W_{0}^{m, p}$, it follows that $I_{k}^{(2)} \rightarrow 0$.
By (3.10) and (A-1), for all $\varepsilon>0$, there are $\delta>0, \Omega^{\prime} \subset \Omega$, with meas $\Omega^{\prime}<\delta$, such that

$$
\begin{equation*}
\int_{\Omega^{\prime}}\left|A_{\alpha}\left(x, \eta_{m-1}\left(u_{n_{k}}\right), \zeta_{m}(u)\right)-A_{\alpha}\left(x, \eta_{m-1}(u), \zeta_{m}(u)\right)\right|^{p^{\prime}}<\varepsilon \tag{3.24}
\end{equation*}
$$

We have from Egoroff theorem and (3.11) $I_{k}^{(1)} \rightarrow 0$. On the other hand, we can conclude from Hölder's inequality that

$$
\begin{equation*}
\lim _{k \rightarrow \infty} \int_{\Omega} A_{\alpha}\left(x, \xi_{m}\left(u_{n_{k}}\right)\right)\left(D^{\alpha} u_{n_{k}}(x)-D^{\alpha} u(x)\right)=0, \quad \text { for } 0 \leq|\alpha| \leq m-1 \tag{3.25}
\end{equation*}
$$

From the above and (3.13) we have that $I_{k}^{(3)} \rightarrow 0$ and $I_{k} \rightarrow 0$. Hence (c1) is established.
Using the same methods as in [13, pages 1835-1836], we obtain that (c2) holds. The proof of Lemma 3.1 is complete.

Proof of Theorem 2.1. We will verify the geometric assumptions of the Mountain Pass Lemma.
(i) There exists $\rho>0, \beta>0:\|u\|_{m, p}=\rho \Rightarrow I(u) \geq \beta$.

Let $\lambda=\lambda_{1}-2 \delta>0, \delta>0$. For all $u \in W_{0}^{m, p}(\Omega)$, there holds

$$
\begin{align*}
I(u) & =\int_{\Omega} \Gamma\left(x, \xi_{m}(u)\right) d x-\frac{\lambda}{p} \int_{\Omega}|u|^{p} d x-\int_{\Omega} F(x, u) d x \\
& \geq \frac{\delta}{p}\|u\|_{p}^{p}+\frac{\delta c_{0} c_{3}^{p}}{\lambda_{1} p c_{5}}\|u\|_{m, p}^{p}-\int_{\Omega} F(x, u) d x . \tag{3.26}
\end{align*}
$$

From (f-3), for all $\varepsilon>0, \exists \rho_{0}=\rho_{0}(\varepsilon)$ such that if $0<\rho=\|u\|_{m, p}<\rho_{0}$, then

$$
\begin{equation*}
|f(x, u)|<\varepsilon|u|^{p-1} \tag{3.27}
\end{equation*}
$$

Thus,

$$
\begin{equation*}
\int_{\Omega} F(x, u) d x=\int_{\Omega} \int_{0}^{u} f(x, t) d t d x \leq \frac{\varepsilon}{p} \int_{\Omega}|u|^{p} d x \leq \frac{C_{2} \varepsilon}{p}\|u\|_{m, p} \tag{3.28}
\end{equation*}
$$

Taking $C_{2}=\left(\delta c_{0} c_{3}^{p}\right) /\left(2 \lambda_{1} c_{5}\right)$, from (3.26) and (3.28), we have

$$
\begin{equation*}
I(u) \geq \beta>0 \tag{3.29}
\end{equation*}
$$

(ii) There exists $u_{0} \in W_{0}^{m, p}(\Omega):\left\|u_{0}\right\|_{m, p} \geq \rho$ and $I\left(u_{0}\right)<0$.

In fact, from (f-2), (f-3), we can deduce that there exist constants $c_{3}^{\prime}, c_{4}^{\prime}$ such that

$$
\begin{equation*}
F(x, u) \geq c_{3}^{\prime}|u|^{\theta}-c_{4}^{\prime}, \quad \forall u \in W_{0}^{m, p}(\Omega) \tag{3.30}
\end{equation*}
$$

Since $\theta>\rho$, a simple calculation shows that

$$
\begin{equation*}
I\left(t u_{0}\right) \leq t^{p} \int_{0}^{1} Q\left(t u_{0}, u_{0}\right) d t-\frac{\lambda t^{p}}{p} \int_{\Omega}\left|u_{0}\right|^{p} d x-c_{3}^{\prime} t^{\theta} \int_{\Omega}\left|u_{0}\right|^{\theta} d x+c_{4}^{\prime}|\Omega| \tag{3.31}
\end{equation*}
$$

The above implies that $I\left(t u_{0}\right) \rightarrow-\infty$, as $t \rightarrow \infty$.
Thus by the Mountain Pass Lemma, $I(u)$ possesses a nontrivial critical point, and the proof of the Theorem 2.1 is complete.

Corollary 3.2. Assume that $Q$ given by (1.2) satisfies ( $Q-1)-(Q-3), A_{\alpha}\left(x, \xi_{m}\right)$ satisfies $(A-1)-(A-4)$, $\lambda \in\left(0, \lambda_{1}\right)$, and $f$ satisfies $(f-2),(f-3)$, and the condition $(f-4)$. There exist constants $c_{1}^{\prime}>, c_{2}^{\prime}>$, for all $x \in \Omega$, such that

$$
\begin{equation*}
|f(x, u)| \leq c_{1}^{\prime}|u|^{q-1}+c_{2}^{\prime} \tag{3.32}
\end{equation*}
$$

where $1<q<p^{*}, p^{*}=N p /(N-m p)$. Then problem (2.7) has nontrivial weak solutions.
