# EINSTEIN-HILBERT TYPE ACTION ON SPACETIMES

#### Abstract

The mixed gravitational field equations have been recently introduced for codimension one foliated manifolds, e.g. stably causal and globally hyperbolic spacetimes. These Euler-Lagrange equations for the total mixed scalar curvature (as analog of Einstein-Hilbert action) involve a new kind of Ricci curvature (called the mixed Ricci curvature). In the work, we derive Euler-Lagrange equations of the action for any spacetime, in fact, for a pseudo-Riemannian manifold endowed with a non-degenerate distribution. The obtained equations are presented in the classical form of Einstein field equation with the new Ricci type curvature instead of Ricci curvature.


## Introduction

Distributions on a manifold $M$ (i.e., subbundles of $T M$ ) appear in various situations, e.g. as fields of tangent planes of foliations or kernels of differential forms, and many models in physics are foliated, e.g., twisted or warped products.

Let $(M, g)$ be a pseudo-Riemannian manifold endowed with non-degenerate distribution $\mathcal{D} \subset T M$. The mixed scalar curvature, $S_{\text {mix }}$ (that is an averaged sectional curvature of planes that non-trivially intersect $\mathcal{D}$ and its orthogonal complement), see (1.1) and 11, is one of the simplest curvature invariants of a manifold endowed with a distribution. Note that from a mathematical point of view, a spacetime is described as a $d$-dimensional, time-orientable manifold, equipped with a Lorentzian metric, there also exists a timelike unit vector field $N$, whose orthogonal distribution is not necessarily integrable. Recall [3, 4] that stably causal and, in particular, globally hyperbolic spacetimes are naturally endowed with a codimension-one foliation (that is level hypersurfaces of a time-function). If $\mathcal{D}$ is spanned by $N$ such that $g(N, N)=\varepsilon_{N} \in\{-1,1\}$, then $S_{\text {mix }}=\varepsilon_{N} \operatorname{Ric}_{N, N}$, where $\operatorname{Ric}_{N, N}$ is the Ricci curvature in the $N$-direction.

The mixed Einstein-Hilbert action has been introduced in 11 as analog of the Einstein-Hilbert action, with the scalar curvature replaced by $S_{\text {mix }}$ :

Here $\Lambda$ is the cosmological constant, $\mathcal{L}$-Lagrangian describing the matter contents, and $\mathfrak{a}$-the coupling constant. The integral is taken over $M$ if it converges; otherwise, one integrates over an arbitrarily large, relatively compact domain $\Omega$ containing supports of variations $g_{t}$ with $g_{0}=g$. The physical meaning of (0.1) has been discussed in 1 for the case of a globally hyperbolic spacetime $\left(M^{4}, g\right)$ when $\mathcal{D}=\operatorname{Span}(N)$ and hence $S_{\text {mix }}=g(N, N) \operatorname{Ric}_{N, N}$, and the following have been obtained: the Euler-Lagrange equations, see (3.12), called the mixed gravitational field equations; sufficient conditions for existence of solutions for empty space, the conservation law analogous to conservation law of stress-energy tensor in relativity; equations of motion of a particle on isoparametric foliations in the "mixed gravitational field"; the linearized mixed field equations about the Minkowski metric; the value of coupling constant $\mathfrak{a}$ in the weak field and low velocity limit.

In this paper, we explore (0.1) for any spacetime, the obtained mixed gravitational field equations generalize the result of [1]. In fact, we work in arbitrary number of dimensions of a pseudo-Riemannian manifold endowed with a distribution, and also generalize certain results of [2, 区, where the particular case of variations of metric (called adapted variations) has been examined. In this setting, we present the Euler-Lagrange equations for (0.1) in the classical form of the Einstein field equations:

where $\Theta$ is the stress-energy tensor, while the Ricci tensor and scalar curvature are replaced by a new Ricci type curvature and its trace. Consequently, (0.2) contains the new mixed Einstein tensor $\mathrm{G}_{\mathcal{D}}:=\operatorname{Ric}_{\mathcal{D}}-(1 / 2) \operatorname{Scal}_{\mathcal{D}} \cdot g$, whose properties should be further investigated. The following equations with $\operatorname{Ric}_{\mathcal{D}}$ seem to be interesting to solve w.r.t. $g$ (this issue will be addressed in further work): (i) (0.2) in vacuum, i.e., for $\Lambda=\Theta=0$; (ii) $\operatorname{Ric}_{\mathcal{D}}(g)=\lambda g$, i.e., the "mixed Einstein metrics"; (iii) the mixed Ricci equation: $\operatorname{Ric}_{\mathcal{D}}=r$ for a given $(0,2)$-tensor $r$; (iv) the mixed Ricci flow: $\partial_{t} g_{t}=-2 \operatorname{Ric}_{\mathcal{D}}\left(g_{t}\right) ;(\mathrm{v})$ the Yamabe-type problem: $\operatorname{Scal}_{\mathcal{D}}(g)=$ const.

The paper has an introduction and three sections. Section 1 reviews necessary definitions of tensors. Section 2 starts with variation formulas for quantities on a manifold with a distribution. Using them, we deduce Euler-Lagrange equations of (0.1), which generalize results in [2, 8] and use them to build the mixed Ricci tensor $\operatorname{Ric}_{\mathcal{D}}$ obeying (0.2). In Proposition 2.2 we observe that the replacement of $S_{\text {mix }}$ by $\mathrm{Scal}_{\mathcal{D}}$ in (0.1) leads to the same Euler-Lagrange equations (0.2). In Section 3 we explore $\operatorname{Ric}_{\mathcal{D}}$ for spacetimes, see (3.6); for integrable $\mathcal{D}$ we compare the tensor, see (3.10), with its initial prototype defined in [1] for globally hyperbolic spacetimes.

## 1. Preliminaries

The section reviews necessary definitions of tensors, some of them were introduced in [8, 11. We consider a connected manifold $M^{n+p}$ with a pseudoRiemannian metric $g$ and a non-degenerate distribution $\mathcal{D}$ of rank $\operatorname{dim} \mathcal{D}_{x}=n$ for
every $x \in M$. A distribution (i.e., a subbundle) $\mathcal{D} \subset T M$ is non-degenerate, if $\mathcal{D}_{x} \subset T_{x} M$ is a non-degenerate subspace of $g_{x}$ for every $x \in M$; in this case, its $g$-orthogonal complement $\mathcal{D}^{\perp}$ is also non-degenerate. A pair $\left(\mathcal{D}, \mathcal{D}^{\perp}\right)$ of complementary orthogonal distributions is called an almost product structure on $(M, g), \mathbf{5}$.

Let $\mathfrak{X}_{M}$ (resp., $\mathfrak{X}_{\mathcal{D}}$ ) be the module over $C^{\infty}(M)$ of all vector fields on $M$ (resp. on $\mathcal{D}$ ). The "musical" isomorphisms $\sharp$ and $b$ are used for rank one tensors, e.g. if $\omega \in T_{0}^{1}(M)$ is a 1-form and $X \in \mathfrak{X}_{M}$ then $\omega(X)=g\left(\omega^{\sharp}, X\right)=X^{b}\left(\omega^{\sharp}\right)$. For (0,2)tensors $A$ and $B$ we have $\langle A, B\rangle=\operatorname{Tr}_{g}\left(A^{\sharp} B^{\sharp}\right)=\left\langle A^{\sharp}, B^{\sharp}\right\rangle$. We get $X=X^{\top}+X^{\perp}$, where $X^{\top}$ is the $\mathcal{D}$-component of $X \in \mathfrak{X}_{M}$ w.r.t. $g$. Thus, $g=g^{\top}+g^{\perp}$, where

g^{\perp}(X, Y)=g\left(X^{\perp}, Y^{\perp}\right), \quad g^{\top}(X, Y)=g\left(X^{\top}, Y^{\top}\right), \quad\left(X, Y \in \mathfrak{X}_{M}\right)
$$

The following convention is adopted for the range of indices:

a, b, c, \ldots \in\{1, \ldots, n\}, \quad i, j, k, \ldots \in\{1, \ldots, p\}, \quad n+p>2 .
$$

It will be convenient to use orthogonal frames with certain nice properties. It is not hard to show that the local adapted orthonormal frame $\left\{E_{a}, \mathcal{E}_{i}\right\}$, where $\left\{E_{a}\right\} \subset \mathcal{D}$, and $\varepsilon_{i}=g\left(\mathcal{E}_{i}, \mathcal{E}_{i}\right) \in\{-1,1\}, \varepsilon_{a}=g\left(E_{a}, E_{a}\right) \in\{-1,1\}$, always exists on $M$.

We will define several tensors for one of distributions (say, $\mathcal{D}$; similar tensors for $\mathcal{D}^{\perp}$ will be denoted using ${ }^{\perp}$ notation). Let $\nabla$ be the Levi-Civita connection of $g$. The integrability tensor and the second fundamental form of $\mathcal{D}$, are given by

T(X, Y)=(1 / 2)\left[X^{\top}, Y^{\top}\right]^{\perp}, \quad h(X, Y)=(1 / 2)\left(\nabla_{X^{\top}}\left(Y^{\top}\right)+\nabla_{Y^{\top}} X^{\top}\right)^{\perp}
$$

respectively. We use inner products of tensors, e.g.

\langle h, h\rangle & =\sum_{a, b} \varepsilon_{a} \varepsilon_{b} g\left(h\left(E_{a}, E_{b}\right), h\left(E_{a}, E_{b}\right)\right), \\
\langle T, T\rangle & =\sum_{a, b} \varepsilon_{a} \varepsilon_{b} g\left(T\left(E_{a}, E_{b}\right), T\left(E_{a}, E_{b}\right)\right) .
\end{aligned}

The mean curvature vector of $\mathcal{D}$ is $H=\operatorname{Tr}_{g} h=\sum_{a} \varepsilon_{a} h\left(E_{a}, E_{a}\right)$. A distribution $\mathcal{D}$ is called totally umbilical, harmonic, or totally geodesic, if $h=\frac{1}{n} H g_{\mid \mathcal{D}}, H=0$, or $h=0$, resp. The Weingarten operator $A_{Z}$ of $\mathcal{D}$ w.r.t. $Z \in \mathfrak{X}_{\mathcal{D}^{\perp}}$, and the operator $T_{Z}^{\sharp}$ are defined by

g\left(A_{Z}(X), Y\right)=g(h(X, Y), Z), \quad g\left(T_{Z}^{\sharp}(X), Y\right)=g(T(X, Y), Z) .
$$

We will use the following convention for indices of various tensors: $T_{i}^{\sharp}:=T_{\mathcal{E}_{i}}^{\sharp}, A_{i}:=$ $A_{\mathcal{E}_{i}}$, etc. Define a self-adjoint (1,1)-tensor $\mathcal{T}=\sum_{i} \varepsilon_{i}\left(T_{i}^{\sharp}\right)^{2}$ and a self-adjoint (1, 1)tensor with zero trace

\mathcal{K}:=\sum_{i} \varepsilon_{i}\left[T_{i}^{\sharp}, A_{i}\right]=\sum_{i} \varepsilon_{i}\left(T_{i}^{\sharp} A_{i}-A_{i} T_{i}^{\sharp}\right),
$$

which vanishes when $\mathcal{D}$ is either integrable or totally umbilical. Define (1, 2)-tensors

$$
\begin{aligned}
\alpha(X, Y) & =\left(A_{X^{\perp}}\left(Y^{\top}\right)+A_{Y^{\perp}}\left(X^{\top}\right)\right) / 2, \\
\theta(X, Y) & =\left(T_{X^{\perp}}^{\sharp}\left(Y^{\top}\right)+T_{Y^{\perp}}^{\sharp}\left(X^{\top}\right)\right) / 2, \\
\delta_{Z}(X, Y) & =\left(g\left(\nabla_{X^{\top}} Z, Y^{\perp}\right)+g\left(\nabla_{Y^{\top}} Z, X^{\perp}\right)\right) / 2 .
\end{aligned}
$$

Note that $\alpha, \theta$ and $\delta_{Z}$ are symmetric and vanish for $(X, Y) \in\left(\mathcal{D}^{\perp} \times \mathcal{D}^{\perp}\right) \cup(\mathcal{D} \times \mathcal{D})$.

For any ( 0,2 )-tensors $P, Q$ and $S$ on $T M$, define a tensor $\Upsilon_{P, Q}$ by

\left\langle\Upsilon_{P, Q}, S\right\rangle=\sum_{\nu, \mu} \varepsilon_{\nu} \varepsilon_{\mu}\left[S\left(P\left(e_{\nu}, e_{\mu}\right), Q\left(e_{\nu}, e_{\mu}\right)\right)+S\left(Q\left(e_{\nu}, e_{\mu}\right), P\left(e_{\nu}, e_{\mu}\right)\right)\right]
$$

where $\left\{e_{\nu}\right\}$ is a local orthonormal basis of $T M$ and $\varepsilon_{\nu}=g\left(e_{\nu}, e_{\nu}\right) \in\{-1,1\}$.
Notice the properties $\Upsilon_{P, Q}=\Upsilon_{Q, P}$ and $\Upsilon_{P, Q_{1}+Q_{2}}=\Upsilon_{P, Q_{1}}+\Upsilon_{P, Q_{2}}$.
The curvature tensor is given by $R_{X, Y} Z=\nabla_{[X, Y]} Z-\left[\nabla_{X}, \nabla_{Y}\right] Z$. The function

S_{\mathrm{mix}}=\sum_{a, i} \varepsilon_{a} \varepsilon_{i} g\left(R_{a, i} E_{a}, \mathcal{E}_{i}\right) \tag{1.1}
\end{equation*}
$$

is called the mixed scalar curvature of $\mathcal{D}$ (or $\mathcal{D}^{\perp}$ ) w.r.t. $g$. The following formula, see [11, has many applications and is used in the proof of Theorem 2.1 below:

S_{\text {mix }}=\operatorname{div} & \left(H+H^{\perp}\right)+g(H, H)-\langle h, h\rangle+\langle T, T\rangle  \tag{1.2}\\
& +g\left(H^{\perp}, H^{\perp}\right)-\left\langle h^{\perp}, h^{\perp}\right\rangle+\left\langle T^{\perp}, T^{\perp}\right\rangle .
\end{align*}

The projection of the gradient of $f \in C^{1}(M)$ onto $\mathcal{D}$ is $\nabla^{\top} f:=(\nabla f)^{\top}$. The $\mathcal{D}$ Laplacian of $f \in C^{2}(M)$ is $\Delta^{\top} f=\operatorname{div}^{\top}\left(\nabla^{\top} f\right)$. The $\mathcal{D}^{\perp}$-divergence of $X \in \mathfrak{X}_{M}$ is defined by $\operatorname{div}^{\perp} X=\sum_{i} \varepsilon_{i} g\left(\nabla_{i} X, \mathcal{E}_{i}\right)$. Thus, $\operatorname{div} X=\operatorname{div}^{\perp} X+\operatorname{div}^{\top} X$. For $X \in \mathfrak{X}_{\mathcal{D}^{\perp}}$ we have $\operatorname{div}^{\perp} X=\operatorname{div} X+g(X, H)$. Similarly, for a $(1,2)$-tensor $P$, define a $(0,2)$-tensor $\operatorname{div} P=\operatorname{div}^{\top} P+\operatorname{div}^{\perp} P$, where

\left(\operatorname{div}^{\perp} P\right)(X, Y)=\sum_{i} \varepsilon_{i} g\left(\left(\nabla_{i} P\right)(X, Y), \mathcal{E}_{i}\right), \quad X, Y \in \mathfrak{X}_{M}

For a $\mathcal{D}^{\perp}$-valued $(0,2)$-tensor $P$, using $\langle P, H\rangle(X, Y):=g(P(X, Y), H)$ we obtain

\operatorname{div}^{\perp} P=\operatorname{div} P+\langle P, H\rangle \tag{1.3}
\end{equation*}

## 2. Euler-Lagrange equations for variations of metric

The section contains the Euler-Lagrange equations of the variational principle $\delta J_{\mathcal{D}, \Omega}(g)=0$ on a relatively compact domain $\Omega$ of a manifold $M$ endowed with a distribution $\mathcal{D}$. We consider variations $\left\{g_{t}\right\}_{|t|<\varepsilon}$ of metric $g_{0}=g$ on $M$ such that the induced infinitesimal variations, presented by a symmetric ( 0,2 )-tensor $B_{t} \equiv$ $\partial g_{t} / \partial t$, are supported in $\Omega \subset M$. We adopt the notations $\partial_{t} \equiv \partial / \partial t, B \equiv \partial_{t} g_{t \mid t=0}$. For a (0,2)-tensor $C$ we have $\langle C, B\rangle=\langle\operatorname{Sym}(C), B\rangle$.

Given $\mathcal{D}$, its $g_{t}$-orthogonal complement $\mathcal{D}_{t}^{\perp}$ depends on $t$; hence, the $g_{t}$-projections onto $\mathcal{D}$ (denoted by ${ }^{\top}$ ) and onto $\mathcal{D}_{0}^{\perp}=\mathcal{D}^{\perp}$ (denoted by ${ }^{\perp}$ ) also depend on $t$. If $\left(g_{t}\right)$ preserve orthogonality of $\mathcal{D}$ and $\mathcal{D}^{\perp}$ then projections ${ }^{\top}$ and ${ }^{\perp}$ do not depend on $t$, and we obtain adapted variations, see [2, $\mathbf{8}$. Among adapted variations, those preserving metric on $\mathcal{D}$ will be called $g^{\perp}$-variations.

Recall [10] that $\nabla^{t}$ (the Levi-Civita connection of $g_{t}$ ) is evolved as

2 g_{t}\left(\partial_{t}\left(\nabla_{X}^{t} Y\right), Z\right)=\left(\nabla_{X}^{t} B\right)(Y, Z) & +\left(\nabla_{Y}^{t} B\right)(X, Z)  \tag{2.1}\\
& -\left(\nabla_{Z}^{t} B\right)(X, Y), \quad X, Y, Z \in \mathfrak{X}_{M} .
\end{align*}

Using (2.1), one may choose a nice evolution of a local orthonormal frame.

Lemma 2.1. Let a local ( $\left.\mathcal{D}, \mathcal{D}^{\perp}\right)$-adapted and orthonormal for $t=0$ frame $\left\{E_{a}(t), \mathcal{E}_{i}(t)\right\}$ be evolved by $\left\{g_{t}\right\}_{|t|<\varepsilon}$ according to

$$
\partial_{t} E_{a}=-(1 / 2) B_{t}^{\sharp}\left(E_{a}\right)^{\top}, \quad \partial_{t} \mathcal{E}_{i}=-(1 / 2) B_{t}^{\sharp}\left(\mathcal{E}_{i}\right)^{\perp}-B_{t}^{\sharp}\left(\mathcal{E}_{i}\right)^{\top} .
$$

Then $\left\{E_{a}(t), \mathcal{E}_{i}(t)\right\}$ is a $g_{t}$-orthonormal frame and $\left\{E_{a}(t)\right\} \subset \mathcal{D},\left\{\mathcal{E}_{i}(t)\right\} \subset \mathcal{D}_{t}^{\perp}$.
Using (2.1), Lemma 2.1 and decomposition of tensor fields w.r.t. $g=g^{\top}+g^{\perp}$, we obtain variation formulas (for detailed proof the reader is referred to [9]).

Proposition 2.1. For any variation $g_{t}$ of metric on $M$ we have at $t=0$

\partial_{t}\left\langle h^{\perp}, h^{\perp}\right\rangle= & \left\langle\operatorname{div} h^{\perp}-4 \Upsilon_{\alpha^{\perp}, \theta}+\mathcal{K}^{b}-\frac{1}{2} \Upsilon_{h^{\perp}, h^{\perp}}, B\right\rangle-\operatorname{div}\left(\left\langle h^{\perp}, B\right\rangle\right), \\
\partial_{t} g_{t}\left(H^{\perp}, H^{\perp}\right)= & \left\langle\left(\operatorname{div} H^{\perp}\right) g^{\perp}+4\left\langle\theta, H^{\perp}\right\rangle-H^{\perp b} \otimes H^{\perp b}, B\right\rangle-\operatorname{div}\left(\left(\operatorname{Tr}_{\mathcal{D}^{\perp}} B^{\sharp}\right) H^{\perp}\right), \\
\partial_{t}\langle h, h\rangle= & \left\langle\operatorname{div} h+\mathcal{K}^{b}-2 \operatorname{div} \alpha-2 \Upsilon_{\alpha, \alpha^{\perp}+\theta^{\perp}}-\frac{1}{2} \Upsilon_{h, h}, B\right\rangle+\operatorname{div}(\langle 2 \alpha-h, B\rangle), \\
\partial_{t} g_{t}(H, H)= & \left\langle 2\left\langle\theta^{\perp}-\alpha^{\perp}, H\right\rangle+2 \operatorname{Sym}\left(H^{b} \otimes H^{\perp b}\right)\right. \\
& \left.-2 \delta_{H}+(\operatorname{div} H) g^{\top}-H^{b} \otimes H^{b}, B\right\rangle+\operatorname{div}\left(2\left(B^{\sharp} H\right)^{\top}-\left(\operatorname{Tr}_{\mathcal{D}} B^{\sharp}\right) H\right), \\
\partial_{t}\left\langle T^{\perp}, T^{\perp}\right\rangle= & \left\langle 2 \mathcal{T}^{\perp b}+2 \Upsilon_{\theta \perp, \theta-\alpha}-2 \operatorname{div} \theta^{\perp}+\frac{1}{2} \Upsilon_{T^{\perp}, T^{\perp}}, B\right\rangle+\operatorname{div}\left(2\left\langle\theta^{\perp}, B\right\rangle\right), \\
\partial_{t}\langle T, T\rangle= & \left\langle\frac{1}{2} \Upsilon_{T, T}+2 \mathcal{T}^{b}, B\right\rangle,
\end{aligned}

Remark 2.1. Formulas of Proposition[2.1] can be presented in three-component form, in which $\mathcal{D} \times \mathcal{D}$-and $\mathcal{D}^{\perp} \times \mathcal{D}^{\perp}$-components are dual, i.e., of the same form with interchanged $\mathcal{D}$ and $\mathcal{D}^{\perp}$. For example, for $g^{\top}$-variations we obtain the following:

\partial_{t}\left\langle h^{\perp}, h^{\perp}\right\rangle & =-\left\langle\Upsilon_{h^{\perp}, h^{\perp}}, B\right\rangle / 2, \\
\partial_{t} g_{t}\left(H^{\perp}, H^{\perp}\right) & =-\left\langle H^{\perp b} \otimes H^{\perp b}, B\right\rangle, \\
\partial_{t}\langle T, T\rangle & =2\left\langle\mathcal{T}^{\triangleright}, B\right\rangle, \\
\partial_{t}\left\langle T^{\perp}, T^{\perp}\right\rangle & =\left\langle\Upsilon_{T^{\perp}, T^{\perp}}, B\right\rangle / 2 .

Assume that the Lagrangian can be written as a sum of two terms $\mathcal{L}_{g r}+\mathcal{L}$, where $\mathcal{L}_{g r}=\frac{1}{2 \mathfrak{a}}\left(S_{\text {mix }}-2 \Lambda\right)$ is the gravity Lagrangian, see (0.1), and the matter Lagrangian $\mathcal{L}$ depends only on $g$ and not on its derivatives. Set $J: g \mapsto \int_{\Omega} \mathcal{L}(g) d \operatorname{vol}_{g}$ on $M$. Variation of the metric $g$ with $B=\partial_{t} g_{t \mid t=0}$ produces the stress-energy tensor $\Theta$ such that

\frac{d}{d t} J\left(g_{t}\right)_{\mid t=0}=\frac{1}{2} \int_{\Omega}\langle\Theta, B\rangle d \operatorname{vol}_{g}
$$

and which governs the interaction of the "gravitational field" with the given field representing the matter. Note that, see [1],

\Theta_{\mu \nu}=-2 \frac{\partial \mathcal{L}}{\partial g^{\mu \nu}}+g_{\mu \nu} \mathcal{L}, \quad\left(2 \frac{\partial \mathcal{L}}{\partial g_{\mu \nu}}+g^{\mu \nu} \mathcal{L}\right) B_{\mu \nu}=\Theta^{\mu \nu} B_{\mu \nu}=\langle\Theta, B\rangle .
$$

The product $T M \times T M$ is the sum of three subbundles, $\mathcal{D}^{\perp} \times \mathcal{D}^{\perp}, \mathcal{D} \times \mathcal{D}$ and

Definition 2.1. The symmetric $(0,2)$-tensor $\operatorname{Ric}_{\mathcal{D}}$ defined by

\operatorname{Ric}_{\mathcal{D} \mid V}= & 2 \delta_{H}+2 \operatorname{div}\left(\theta^{\perp}-\alpha\right)-4\left\langle\theta, H^{\perp}\right\rangle-2\left\langle\theta^{\perp}-\alpha^{\perp}, H\right\rangle \\
& -4 \Upsilon_{\alpha^{\perp}, \theta}-2 \Upsilon_{\alpha, \alpha^{\perp}}-2 \Upsilon_{\theta}{ }^{\perp}, \theta \\
2.2) & \operatorname{Sym}\left(H^{b} \otimes H^{\perp b}\right), \\
\operatorname{Ric}_{\mathcal{D} \mid \mathcal{D} \times \mathcal{D}}= & \operatorname{div} h+\mathcal{K}^{b}-2 \mathcal{T}^{\dagger}+H^{\perp b} \otimes H^{\perp b}-\frac{1}{2} \Upsilon_{h^{\perp}, h^{\perp}}-\frac{1}{2} \Upsilon_{T^{\perp}, T^{\perp}}+\mu g^{\top},

is referred to as the mixed Ricci curvature. The trace of $\operatorname{Ric}_{\mathcal{D}}$ is then

Proposition 2.2. Euler-Lagrange equations for (0.1) are the same as for the action

Proof. For any $X_{t}$ supported on $\Omega$ and any $g_{t}$ we have

$\nu$ being outward-pointing normal unit vector field to $\partial \Omega$. If $\partial_{t} g$ and $\partial_{t} X$ are supported in $\Omega$ then the rhs integral does not depend on $t: \frac{d}{d t} \int_{\Omega} \operatorname{div} X_{t} d \operatorname{vol}_{g_{t}}=0$. Thus, for $X_{t}=\frac{p-n}{n+p-2}\left(H^{\perp}-H\right)$ and by (2.4), if we replace $S_{\text {mix }}$ by Scal ${ }_{\mathcal{D}}$ in (0.1) then get the same Euler-Lagrange equations.

Theorem 2.1 (Euler-Lagrange equations). A metric $g$ on $M$ with nondegenerate $\mathcal{D}$ is critical for (0.1), or equivalently, for (2.5), if and only if $g$ is a solution to (0.2), where $\operatorname{Ric}_{\mathcal{D}}$ is given by (2.2).

Proof. We derive for the gravitational part $J_{\text {mix }, \mathcal{D}, \Omega}: g \mapsto \int_{\Omega} S_{\text {mix }}(g) d \operatorname{vol}_{g}$ of (0.1). By (1.2),

where $Q(g):=S_{\text {mix }}(g)-\operatorname{div}\left(H+H^{\perp}\right)$ is given using (1.2) as
(2.6) $Q(g)=g(H, H)-\langle h, h\rangle_{g}+g\left(H^{\perp}, H^{\perp}\right)-\left\langle h^{\perp}, h^{\perp}\right\rangle_{g}+\langle T, T\rangle_{g}+\left\langle T^{\perp}, T^{\perp}\right\rangle_{g}$.

Recall, see 10, that the volume form is evolved as

& =\int_{\Omega}\left\langle 4\left\langle\theta, H^{\perp}\right\rangle-H^{\perp b} \otimes H^{\perp b}-\operatorname{div} h^{\perp}+4 \Upsilon_{\alpha^{\perp}, \theta}-\mathcal{K}^{b}+\frac{1}{2} \Upsilon_{h^{\perp}, h^{\perp}}\right. \\
& -H^{b} \otimes H^{b}+2\left\langle\theta^{\perp}-\alpha^{\perp}, H\right\rangle+2 \operatorname{Sym}\left(H^{b} \otimes H^{\perp b}\right)-2 \delta_{H}+2 \operatorname{div}\left(\alpha-\theta^{\perp}\right) \\
& +2 \Upsilon_{\alpha, \alpha^{\perp}+\theta^{\perp}}+\frac{1}{2} \Upsilon_{h, h}-\operatorname{div} h-\mathcal{K}^{b}+2 \mathcal{T}^{\perp b}+2 \Upsilon_{\theta \perp, \theta-\alpha}+\frac{1}{2} \Upsilon_{T^{\perp}, T^{\perp}} \\
(2.8) & \left.+\frac{1}{2} \Upsilon_{T, T}+\mathcal{T}^{\downarrow}+\frac{1}{2} S_{\text {mix }} \cdot g+\frac{1}{2} \operatorname{div}\left(H^{\perp}-H\right)\left(g^{\perp}-g^{\top}\right), B\right\rangle d \operatorname{vol}_{g} .
\end{aligned}
$$

If $g$ is critical for $J_{\text {mix }, \mathcal{D}, \Omega}$ w.r.t. all variations $\left(g_{t}\right)$ then the integral in (2.8) is zero for arbitrary symmetric $(0,2)$-tensor $B$. We can further decompose the resulting Euler-Lagrange equations into three independent parts: its $V-, \mathcal{D} \times \mathcal{D}$ - and $\mathcal{D}^{\perp} \times \mathcal{D}^{\perp}$ components. In this way, for the action (0.1) we obtain (2.2). The $\mathcal{D}^{\perp} \times \mathcal{D}^{\perp}$ component $(2.2)_{3}$ is dual to the $\mathcal{D} \times \mathcal{D}$-component (2.2) $)_{1}$. Substituting (2.2) with arbitrary $(\mu, \eta)$ into (0.2), and comparing the result with (2.2), we find $(\mu, \eta)$ in (2.3) as solution of a linear system

$$
(p-2) \eta+n \mu=\operatorname{div}\left(H^{\perp}-H\right), \quad(n-2) \mu+p \eta=-\operatorname{div}\left(H^{\perp}-H\right)

Remark 2.2. Components (2.2) $1_{1}$ and (2.2) 3 can be obtained using adapted variations of metric, see also [8. Component (2.2) 2 is not symmetric under the change $\mathcal{D}^{\perp} \leftrightarrow \mathcal{D}$, because $S_{\text {mix }}\left(g_{t}\right)$ (when $\mathcal{D}$ is fixed) is different from the mixed scalar curvature for $g_{t}$ when $\mathcal{D}^{\perp}$ is fixed while $\mathcal{D}_{t}$ varies. In order to organize better the div-terms in $(\sqrt{2.2})_{2}$, we introduce the symmetric ( 0,2 )-tensor:

Using the Codazzi equation of [5, Theorem 2.4], $V$-component (2.2) $)_{2}$ can be written as

& +2\left\langle\alpha^{\perp}-\theta^{\perp}, H\right\rangle-2 \operatorname{Sym}\left(H^{b} \otimes H^{\perp b}\right)-2 \Upsilon_{\alpha, \alpha^{\perp}}+2 \Upsilon_{\theta, \theta^{\perp}}
\end{align*}
$$

As an immediate consequence of (2.9), we get: if $\mathcal{D}$ and $\mathcal{D}^{\perp}$ are integrable then

\operatorname{Ric}_{\mathcal{D} \mid V}=\operatorname{Ric}^{\top}+2\left\langle\alpha, H^{\perp}\right\rangle+2\left\langle\alpha^{\perp}, H\right\rangle-2 \operatorname{Sym}\left(H^{b} \otimes H^{\perp b}\right)-2 \Upsilon_{\alpha, \alpha^{\perp}}
$$

Corollary 2.1. A metric $g$ on $M$ with non-degenerate $\mathcal{D}$ is critical for the action (0.1) w.r.t. all adapted variations of $g$ if and only if $g$ solves (0.2), where $\operatorname{Ric}_{\mathcal{D}}$ is built from $(2.2)_{1}$ and $(2.2)_{3}$ (that is $\operatorname{Ric}_{\mathcal{D} \mid V}=0$ ).

Next, we will examine (0.2) for generalized product metrics, having many applications. Let $M=M_{1} \times M_{2}$ be a product of pseudo-Riemannian manifolds ( $M_{i}, g_{i}$ ) ( $i=1,2$ ), and let $\pi_{i}: M \rightarrow M_{i}$ and $d \pi_{i}: T M \rightarrow T M_{i}$ be the canonical projections. Given positive twisting functions $\phi, \psi \in C^{\infty}(M)$, a double-twisted product $M_{1} \times{ }_{(\phi, \psi)} M_{2}$ is $M_{1} \times M_{2}$ with the metric $\bar{g}=\phi g^{\top}+\psi g^{\perp}$, where $g^{\top}=\pi_{1}^{*} g_{1}$ and $g^{\perp}=\pi_{2}^{*} g_{2}$. If either $\phi$ or $\psi$ is constant, then we have a twisted product. The leaves $M_{1} \times\{y\}$ (tangent to $\mathcal{D}$ ) and the fibers $\{x\} \times M_{2}$ (tangent to $\mathcal{D}^{\perp}$ ) are totally umbilical in $(M, \bar{g})$ and this property characterizes double-twisted products, see [6]. Recall that $\operatorname{Hess}_{\psi}(X, Y)=\bar{g}\left(\bar{\nabla}_{X}(\bar{\nabla} \psi), Y\right)$ for all $X, Y \in \mathfrak{X}_{M}$.

The next proposition describes $\operatorname{Ric}_{\mathcal{D}}$ for double-twisted products, and shows that the stress-tensor in (0.2) should be of a particular structure. The result can be also used for finding special solutions of the mixed Ricci equation and mixed Einstein metrics mentioned in the introduction.

Proposition 2.3. Let $g=g^{\top}+g^{\perp}$ be a direct product metric on $M=M_{1} \times M_{2}$. Then a double-twisted product metric $\bar{g}=\psi g^{\top}+\phi g^{\perp}$ is critical for (0.1) if and only if $\bar{g}$ solves (0.2) with

\operatorname{Ric}_{\mathcal{D} \mid \mathcal{D}^{\perp} \times \mathcal{D}^{\perp}} & =\left(F_{1}+\Lambda\right) g^{\perp}+F_{2}\left(\nabla^{\perp} \phi\right)^{b} \otimes\left(\nabla^{\perp} \phi\right)^{b}, \\
\operatorname{Ric}_{\mathcal{D} \mid V} & =F_{3}\left(\nabla^{\top} \phi\right)^{b} \otimes\left(\nabla^{\perp} \psi\right)^{b}+F_{4}\left(\operatorname{Hess}_{\psi}\right)_{\mid V},  \tag{2.10}\\
\operatorname{Ric}_{\mathcal{D} \mid \mathcal{D} \times \mathcal{D}} & =\left(F_{5}+\Lambda\right) g^{\top}+F_{6}\left(\nabla^{\top} \psi\right)^{b} \otimes\left(\nabla^{\top} \psi\right)^{b},
\end{align*}
$$

where $\left(F_{5}, F_{6}\right)$ are dual under the change $\left(\mathcal{D}^{\perp}, \psi\right) \leftrightarrow(\mathcal{D}, \phi)$ to $\left(F_{1}, F_{2}\right)$, resp., and

$$
\begin{aligned}
F_{1}= & \frac{n(n-1)}{4} \psi^{-2} g\left(\nabla^{\perp} \psi, \nabla^{\perp} \psi\right)+\left(1-\frac{p}{4}\right)(p-1) \psi^{-1} \phi^{-1} g\left(\nabla^{\top} \phi, \nabla^{\top} \phi\right) \\
& -(p-1) \psi^{-1} \Delta^{\top} \phi+\left(1-\frac{n}{2}\right)(p-1) \psi^{-2} g\left(\nabla^{\top} \psi, \nabla^{\top} \phi\right) \\
F_{2}= & -\frac{n(n-1)}{2} \phi^{-2} \psi^{-2} \\
F_{3}= & -(n-1) \psi^{-1}\left(\frac{p-2}{4} \phi^{-1}-\frac{1}{2} \psi^{-1}\right), \quad F_{4}=\frac{1-n}{2} \psi^{-1} .
\end{aligned}
$$

Note that constant $\phi, \psi$ are the only solutions of (2.10) with $\Lambda=0=\Theta$.

## 3. The mixed Ricci tensor on spacetimes

Let $n=1$. In this case, $\mathcal{D}$ is spanned by a nonsingular vector field $N$, i.e., the distribution tangent to one-dimensional foliation of $\left(M^{p+1}, g\right)$ by $N$-curves. An example of such foliations is provided by a circle action $S^{1} \times M \rightarrow M$ without fixed points. Now, let $g(N, N)=\varepsilon_{N} \in\{-1,1\}$, then $g=g^{\top}+g^{\perp}$, where

$$
\begin{equation*}
g^{\top}=\varepsilon_{N} N^{b} \otimes N^{b} . \tag{3.1}
\end{equation*}
$$

For physically relevant applications, one should take $p=3$ and $\varepsilon_{N}=-1$, while $g_{\mid \mathcal{D} \perp}>0$. Note that $S_{\text {mix }}=\varepsilon_{N} \operatorname{Ric}_{N, N}$, and the action (0.1) reduces itself to

\end{equation*}

For a foliation by $N$-curves we have $T=0$, while $\left\langle T^{\perp}, T^{\perp}\right\rangle=\varepsilon_{N}\left\langle T_{N}^{\perp \sharp}, T_{N}^{\perp \sharp}\right\rangle$. It follows easily that $h=H g^{\top}$ and $\langle h, h\rangle=g(H, H)$, where $H=\varepsilon_{N} \nabla_{N} N$ is the curvature of $N$-lines, and

H^{\perp}=\varepsilon_{N} \tau_{1} N, \quad h^{\perp}=h_{s c}^{\perp} N, \quad g\left(H^{\perp}, H^{\perp}\right)=\tau_{1}^{2}, \quad\left\langle h^{\perp}, h^{\perp}\right\rangle=\tau_{2} \tag{3.3}
\end{equation*}
$$

where $h_{s c}^{\perp}=\varepsilon_{N}\left\langle h^{\perp}, N\right\rangle$ is the scalar second fundamental form of $\mathcal{D}^{\perp}$ and $\tau_{i}$ is the trace of the $i$ th power of $A_{N}^{\perp}$. By (1.3), we obtain

\operatorname{div} h^{\perp}=\nabla_{N} h_{s c}^{\perp}-\tau_{1} h_{s c}^{\perp}, \quad \operatorname{div} h=(\operatorname{div} H) g^{\top} \tag{3.4}

Note that $\operatorname{div} N=-\tau_{1}$ and $\operatorname{div}\left(\tau_{1} N\right)=N\left(\tau_{1}\right)-\tau_{1}^{2}$. Denote by $R_{N}: X \rightarrow R_{N, X} N$ the Jacobi operator of $N$. Recall the identities, see [7, 8],

The $\mathcal{D}$-deformation tensor of $Z \in \mathfrak{X}_{M}$ is the symmetric part of $\nabla Z$ restricted to $\mathcal{D}$ :

Proposition 3.1. For $\mathcal{D}$ spanned by $N$, the symmetric tensor $\mathrm{Ric}_{\mathcal{D}}$ is given by

\operatorname{Ric}_{\mathcal{D}}(\cdot, N)_{\mid \mathcal{D}^{\perp}} & =\operatorname{div}^{\perp}\left(T_{N}^{\perp \sharp}\right)+2\left(T_{N}^{\perp \sharp} H\right)^{b}  \tag{3.6}\\
\operatorname{Ric}_{\mathcal{D}}(N, N) & =\varepsilon_{N}\left(N\left(\tau_{1}\right)-\tau_{2}\right)-\left\langle T^{\perp}, T^{\perp}\right\rangle,
\end{align*}
$$

and its trace is

$$
\operatorname{Scal}_{\mathcal{D}}=\varepsilon_{N} \operatorname{Ric}_{N, N}+\operatorname{div}\left(\varepsilon_{N} \tau_{1} N-H\right)
$$

Due to (3.5), an equivalent form of $\operatorname{Ric}_{\mathcal{D}}$ just involving the curvature tensor is (3.7)

\operatorname{Ric}_{\mathcal{D} \mid \mathcal{D}^{\perp} \times \mathcal{D}^{\perp}}= & \varepsilon_{N}\left(R_{N}+\left(A_{N}^{\perp}\right)^{2}-\left(T_{N}^{\perp \sharp}\right)^{2}+\left[T_{N}^{\perp \sharp}, A_{N}^{\perp}\right]\right)^{b}+H^{b} \otimes H^{b} \\
& -\tau_{1} h_{s c}^{\perp}-\operatorname{Def}_{\mathcal{D}} H-\frac{1}{2}\left(\varepsilon_{N} \operatorname{Ric}_{N, N}+\operatorname{div}\left(\varepsilon_{N} \tau_{1} N-H\right)\right) g^{\perp}, \\
\operatorname{Ric}_{\mathcal{D}}(\cdot, N)_{\mid \mathcal{D}^{\perp}}= & \operatorname{div}^{\perp}\left(T_{N}^{\perp \sharp}\right)+2\left(T_{N}^{\perp \sharp} H\right)^{b}, \\
\operatorname{Ric}_{\mathcal{D}}(N, N)= & \varepsilon_{N} \operatorname{Ric}_{N, N}-4\left\langle T^{\perp}, T^{\perp}\right\rangle-\operatorname{div}\left(\varepsilon_{N} \tau_{1} N+H\right) .
\end{aligned}
$$

Proof. By (2.3), we have $\eta=0$ and $\mu=\varepsilon_{N}\left(N\left(\tau_{1}\right)-\tau_{1}^{2}\right)-\operatorname{div} H$. Substituting values (3.3), (3.4) and

h=H g^{\top}, \quad H^{\perp b} \otimes H^{\perp b}=\varepsilon_{N} \tau_{1}^{2} g^{\top}, \quad \mathcal{K}=0=\mathcal{T}, \\
\Upsilon_{h^{\perp}, h^{\perp}}=2 \varepsilon_{N} \tau_{2} g^{\top}, \quad \Upsilon_{T^{\perp}, T^{\perp}}=2\left\langle T^{\perp}, T^{\perp}\right\rangle g^{\top}
\end{gathered}
$$

into (2.2) 3 yields (3.6) 3 . Note also that $\theta=0$; hence,

$$
\begin{aligned}
2(\operatorname{div} \alpha)(X, N) & =g\left(\nabla_{N} H-\tau_{1} H, X\right), \\
2\left\langle\theta^{\perp}-\alpha^{\perp}, H\right\rangle(X, N) & =-g\left(T_{N}^{\perp \sharp}(H)+A_{N}^{\perp}(H), X\right), \\
2 \operatorname{Sym}\left(H^{\mathrm{b}} \otimes H^{\perp b}\right)(X, N) & =g\left(\tau_{1} H, X\right), \\
2 \delta_{H}(X, N) & =g\left(\nabla_{N} H, X\right), \\
2 \Upsilon_{\alpha, \alpha^{\perp}}(X, N) & =g\left(A_{N}^{\perp}(H), X\right)
\end{aligned}
$$

for all $X$ orthogonal to $N$, and the $V$-component $(2.2)_{2}$ is

$$
\begin{equation*}
\operatorname{Ric}_{\mathcal{D} \mid V}=\operatorname{div} \theta^{\perp}-\left\langle\theta^{\perp}, H\right\rangle \tag{3.8}
\end{equation*}
$$

The lhs of (3.8) vanishes on all pairs of vectors except those from $V$. We have

$$
\begin{aligned}
2 \operatorname{div} \theta^{\perp}(X, N) & =\sum_{i} \varepsilon_{i} g\left(\left(\nabla_{i} T_{N}^{\perp \sharp}\right)(X), \mathcal{E}_{i}\right)+\varepsilon_{N} g\left(\nabla_{N}\left(T_{N}^{\perp \sharp}(X)\right), N\right) \\
& =\operatorname{div}^{\perp}\left(T_{N}^{\perp \sharp}\right)(X)+g\left(T_{N}^{\perp \sharp}(H), X\right)
\end{aligned}
$$

for $X \in \mathfrak{X}_{\mathcal{D}^{\perp}}$ Hence, (3.8) is written as (3.6) 2 . Using (3.5) in (3.6) yields (3.7). The above and (3.1) yield (0.2).

Theorem 2.1 and Proposition 3.1 yield the following.
Corollary 3.1 (The mixed gravitational field equations). A metric $g$ on $M$ with $\mathcal{D}$ spanned by a unit vector field $N$ is critical for (3.2) if and only if $g$ is a solution of (0.2) with $\operatorname{Ric}_{\mathcal{D}}$ given in (3.6). In this case, (0.2) splits into the system

$$
\begin{align*}
& \nabla_{N} h_{s c}^{\perp}-\tau_{1} h_{s c}^{\perp}-\varepsilon_{N}\left(2\left(T_{N}^{\perp \sharp}\right)^{2}+\left[A_{N}^{\perp}, T_{N}^{\perp \sharp}\right]\right)^{b} \\
&+\left\langle T^{\perp}, T^{\perp}\right\rangle-\frac{1}{2}\left(\varepsilon_{N}\left(2 N\left(\tau_{1}\right)-\tau_{1}^{2}-\tau_{2}\right)-2 \Lambda\right) g^{\perp}=\mathfrak{a} \Theta_{\mid \mathcal{D}^{\perp} \times \mathcal{D}^{\perp}}, \\
& \operatorname{div}^{\perp}\left(T_{N}^{\perp \sharp}\right)+2\left(T_{N}^{\perp \sharp} H\right)^{b}=\mathfrak{a} \Theta_{., N \mid \mathcal{D}^{\perp}},  \tag{3.9}\\
& \frac{1}{2} \varepsilon_{N}\left(\tau_{1}^{2}-\tau_{2}\right)-\frac{3}{2}\left\langle T^{\perp}, T^{\perp}\right\rangle+\Lambda=\mathfrak{a} \Theta_{N, N} .
\end{align*}
$$

Example 3.1. Let a unit vector field $N$ generates a geodesic Riemannian flow (i.e., $h^{\perp}=0=h$ ) on a pseudo-Riemannian manifold ( $M^{p+1}, g$ ). In this case,

$$
\operatorname{Ric}_{\mathcal{D}}(X, N)=-\operatorname{Ric}_{X, N}
$$

As an example, consider the Hopf fibration $S^{2 m+1} \rightarrow C P^{m}$, for which $N$ is tangent to the fibers $\left\{S^{1}\right\}$. We have $T^{\perp}(X, Y)=g(J X, Y) N$ for the standard almost complex structure $J$ on $\mathbb{R}^{2 m+2}$ and metric $g>0$, and hence $T_{N}^{\perp \sharp}(X)=J(X)$ and $\left\langle T^{\perp}, T^{\perp}\right\rangle=2 m$. It follows that $\left(\nabla_{Z} T_{N}^{\sharp}\right)(X)=\left(\nabla_{Z} J\right)(X)=0$, and (3.9) 2 is valid with $\Theta_{\mid \mathcal{D}^{\perp} \times \mathcal{D}}=0$. Moreover, (3.9) 1 and (3.9) 3 are satisfied with

$$
\mathfrak{a} \Theta_{\mid \mathcal{D}^{\perp} \times \mathcal{D}^{\perp}}=(2-m+\Lambda) g^{\perp}, \quad \mathfrak{a} \Theta_{N, N}=\Lambda-3 .
$$

The reader can find more examples in [8, $\mathbf{9}$, and for spacetimes, in $\mathbf{1}$.

Corollary 3.2. A metric $g$ on $M$ with non-degenerate $\mathcal{D}=\operatorname{Span}(N)$ and integrable $\mathcal{D}^{\perp}$ is critical for (3.2) if and only if $g$ solves (0.2), where the nonzero components of $\operatorname{Ric}_{\mathcal{D}}$ are given by

$$
\begin{equation*}
\operatorname{Ric}_{\mathcal{D} \mid \mathcal{D}^{\perp} \times \mathcal{D}^{\perp}}=\nabla_{N} h_{s c}^{\perp}-\tau_{1} h_{s c}^{\perp}, \quad \operatorname{Ric}_{\mathcal{D}}(N, N)=\varepsilon_{N}\left(N\left(\tau_{1}\right)-\tau_{2}\right) \tag{3.10}
\end{equation*}
$$

In this case, (0.2) splits into the system

$$
\begin{align*}
\nabla_{N} h_{s c}^{\perp}-\tau_{1} h_{s c}^{\perp}-\frac{1}{2}\left(\varepsilon_{N}\left(2 N\left(\tau_{1}\right)-\tau_{1}^{2}-\tau_{2}\right)-2 \Lambda\right) g^{\perp} & =\mathfrak{a} \Theta_{\mid \mathcal{D}^{\perp} \times \mathcal{D}^{\perp}}  \tag{3.11}\\
\frac{1}{2} \varepsilon_{N}\left(\tau_{1}^{2}-\tau_{2}\right)+\Lambda & =\mathfrak{a} \Theta_{N, N}
\end{align*}
$$

Proof. Since $(\sqrt{3.9})_{2}$ is valid for integrable $\mathcal{D}^{\perp}$, in this case, variations $g_{t}$ constant on $\mathcal{D}$ yield the same Euler-Lagrange equations as adapted $g^{\perp}$-variations.

Action (3.2) has been studied in 1 for a globally hyperbolic spacetime $\left(M^{4}, g\right)$, which is naturally foliated, see [3]. There, $\mathcal{D}=\operatorname{Span}(N)$ with $\varepsilon_{N}=-1$, and $\mathcal{D}^{\perp}$ is integrable (i.e., $T^{\perp}=0$ ). Although Euler-Lagrange equations for (3.2) coincide with (3.11), they are written in [1] in terms of a non-symmetric tensor $\operatorname{Ric}_{\mathcal{D}}^{1}$, which is different from (3.10):

$$
\begin{aligned}
\operatorname{Ric}_{\mathcal{D} \mid \mathcal{D}}^{1} \times \mathcal{D}^{\perp} & =\nabla_{N} h_{s c}^{\perp}-\tau_{1} h_{s c}^{\perp} \\
\operatorname{Ric}_{\mathcal{D}}^{1}(X, N) & =-\operatorname{Ric}_{\mathcal{D}}^{1}(N, X)=\operatorname{div}\left(A_{N}^{\perp}(X)\right), \quad X \in \mathfrak{X}_{\mathcal{D}^{\perp}}, \\
\operatorname{Ric}_{\mathcal{D}}^{1}(N, N) & =\operatorname{div} H,
\end{aligned}
$$

with the trace $\operatorname{Scal}_{\mathcal{D}}^{1}=\varepsilon_{N} \operatorname{Ric}_{N, N}-\varepsilon_{N}\left(\tau_{1}^{2}-\tau_{2}\right)$. Consequently, the mixed gravitational field equations given in [1] are slightly different from (0.2):

$$
\begin{equation*}
\operatorname{Ric}_{\mathcal{D}}^{1}-\frac{1}{2} \operatorname{Scal}_{\mathcal{D}}^{1} \cdot g+\varepsilon_{N} \operatorname{Ric}_{N, N}\left(\frac{1}{2} g-\varepsilon_{N} N^{b} \otimes N^{b}\right)+\Lambda g=\mathfrak{a} \Theta \tag{3.12}
\end{equation*}
$$

Since we actually use the symmetric part of $\operatorname{Ric}_{\mathcal{D}}^{1}$ in (3.12), its left hand side vanishes when evaluated on $(X, N)$. Thus, comparing $\operatorname{Ric}_{\mathcal{D}}$ with $\operatorname{Ric}_{\mathcal{D}}^{1}$, we find

$$
\begin{aligned}
\operatorname{Sym}\left(\operatorname{Ric}_{\mathcal{D}}^{1}\right)-\operatorname{Ric}_{\mathcal{D}} & =\left(\operatorname{div} H-\varepsilon_{N}\left(N\left(\tau_{1}\right)-\tau_{2}\right)\right) g^{\top} \\
\operatorname{Scal}_{\mathcal{D}}^{1}-\operatorname{Scal}_{\mathcal{D}} & =\operatorname{div} H-\varepsilon_{N}\left(N\left(\tau_{1}\right)-\tau_{2}\right)
\end{aligned}
$$

Certainly, (3.12) reduces to (3.11) when evaluated on $\mathcal{D}^{\perp} \times \mathcal{D}^{\perp}$ and $(N, N)$, respectively. This corresponds to the following values of $(\eta, \mu)$ in (2.2) when $n=1$ :

$$
\eta=-\operatorname{div}\left(H^{\perp}-H\right)+\varepsilon_{N} \operatorname{Ric}_{N, N}, \quad \mu=\operatorname{div}\left(H^{\perp}-H\right)-\varepsilon_{N} \operatorname{Ric}_{N, N}
$$

Comparing (3.12) with (0.2) we conclude that (2.3) is the best choice of $(\eta, \mu)$.
