Convergence groups from subgroups

Abstract

We give su cient conditions for a group of homeomorphisms of a Peano continuum X without cut-points to be a convergence group. The condition is that there is a collection of convergence subgroups whose limit sets \cut up" X in the correct fashion. This is closely related to the result in [7].

This paper is part of an approach to the weak hyperbolization conjecture in the case where the three manifold, M, contains an immersed incompressible surface. The idea of the program is to compactify the universal cover of M with a 2{sphere in such a way that $G = {}_{1}(M)$ acts on the 2{sphere as a uniform convergence group, and so by Bowditch, [2], G is word hyperbolic.

The application, in this case, is when X is a 2{sphere and the collection A of subgroups are surface subgroups whose limit sets are circles.

We prove the result in the setting of metric spaces, but it is also true in the more general setting of Hausdor spaces, and the proof goes through with only minor modi cations.

De nition of convergence I We say a group G acting by homeomorphism on a space X acts as a *convergence group* on X if for each sequence of distinct elements of G, there is a subsequence (g_i) and points $p; n \ 2 \ X$ such that for any compact $C \ B \ n$ and any neighborhood U of p there is an $K \ 2 \ N$ such that for all i > K, $g_i(C)$ U. (See gure 1.)

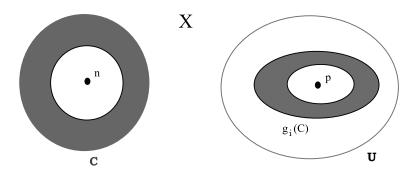

Remark 1 It is easily shown that G fails to act properly on Y if and only if there exists a sequence (v_i) in Y and a sequence of distinct group elements (g_i) in G such that v_i ! v 2 Y and $g_i(v_i)$! v 2 Y

De nition of convergence II We say a group G which acts by homeomorphisms on a space X is a *convergence group* on X if the induced action on the space

$$4X = fT$$
 $X: jTj = 3g$

of distinct triples of X is proper. Notice that 4X is a quotient of a subset of X^3 by the action of S_3 (permuting coordinates), and this de nes the topology on 4X.

In [1], these two de nitions are shown to be equivalent in the case where \boldsymbol{X} is compact Hausdor .

De nition A *Peano* continuum is a compact connected locally connect metric space. In a continuum Y, we say that A = Y *separates* the sets B; C = Y if B and C lie in different components of Y - A. In a Peano continuum X, we say that closed sets A; B = X *cross* if $A \setminus B \neq Y$, A separates points of B, or B separates points of A.

De nition Let X be a Peano continuum, and G be a group which acts by homeomorphisms on X. If A is a G{invariant collection of closed subsets of X, we say that the pair (G;A) is a nepairing on X if the following conditions are satis ed:

- (1) A is *cross connected*, that is for any $A : B \ 2 \ A$ there are $A_1 : A_2 : ... : A_n \ 2$ A with $A_1 = A$, $A_n = B$, where A_i crosses A_{i+1} for 0 < i < n.
- (2) A is *null*. That is: For any > 0, the set of elements of A with diameter at least , $fA \ 2 \ A : diam(A) > q$ is nite.
- (3) A is ne. That is: For any x; y 2 X there exists a nite B A such that [B separates x from y.

We need the following two results from continuum theory.

Lemma 1 If M is a Peano continuum and a closed set A does not separate the closed connected set B from the closed connected set C, then there exists a neighborhood V of A which does not separate B from C. (We are of course assuming that $A \setminus (B \mid C) = :$.)

Proof For $x, y \in M$ – A, de ne x = y if there exist a closed neighborhood D of A which does not separate x from y. Clearly B is in a single equivalence class as is C. Let $b \in B$. De ne $W = fx \in M$ – A : x = bg. Since W is the union of components of open sets of M, and M is locally connected, it follows that W is open in M. Notice that $\overline{W} = W \in A$ and so W is closed in M - A. Thus W is a component of M - A and so W = C. It follows that there is a closed neighborhood $V = M - (B \in C)$ of A which does not separate some point of C from B, and so V does not separate B from C.

Lemma 2 Given Z, a Peano continuum, for any > 0 there is > 0 such that if A; B are crossing closed sets of X with diam(A) < and <math>diam(B) < a, then $diam(A \ [B) < a$.

Proof Suppose not, then for some > 0 there are sequencea (A_n) and (B_n) of closed subsets of X with A_n crossing B_n for each n, $diam(A_n)$; $diam(B_n) < \frac{1}{n}$, but $diam(A_n [B_n))$ for all n. Using compactness, we may assume that $A_n ! \ a \ 2 \ X$ and $B_n ! \ b \ 2 \ X$ which implies that d(a;b). Choose disjoint connected neighborhoods U and V of a and b respectively. For all n >> 0, $A_n \ U$ and $B_n \ V$, which implies that A_n and $A_n \ D$ do not cross. \square

Lemma 3 Let (G; A) be a ne pairing on X and B A with B nite and cross connected. If (g_i) is a sequence of elements of G then either $(g_i([B))$ is null, that is 8 > 0; 9N such that $diam(g_i([B)) < whenever <math>i > N$, or there exists $B \ 2 \ B$, $A \ 2 \ A$ and a subsequence (g_{i_n}) of (g_i) with $g_{i_n}(B) = A$ for all n.

Proof We assume that $(g_i([B))$ is not null. By Lemma 2 there is $B \ 2 \ B$ with $(g_i(B))$ not null. Thus there is > 0 and a subsequence (g_{i_m}) with $diam(g_{i_m}(B)) >$ for all m. Since A is null, the set $fg_{i_m}(B)g$ is nite and the result follows.

Main Theorem Let X be a Peano continuum without cut points, and (G; A) is a nepairing on X. If, for each $A \supseteq A$, Stab(A) acts as a convergence group on X, then G acts as a convergence group on X.

Proof We will show that G acts properly on 4X. Assume not, then we have a sequence (\mathbf{v}_i) in 4X and a sequence of distinct group elements (g_i) in G such that \mathbf{v}_i ! \mathbf{v} 2 4X and $g_i(\mathbf{v}_i)$! \mathbf{w} 2 4X. We may assume we have $\mathbf{v}_i = fx_i^1; x_i^2; x_i^3 g$, $\mathbf{v} = fx_i^1; x_i^2; x_i^3 g$ and $\mathbf{w} = fy_i^1; y_i^2; y_i^3 g$ with x_i^j ! x_i^j and $g_i(x_i^j)$! y_i^j for j = 1; 2; 3.

For j = 1/2/3 choose a nite B^j A with $x^j \ 2 \ V^j$, a component of $X - [B^j]$. Using neness (and compactness of X) we can arrange that $\overline{V^j} \setminus \overline{V^k} = j$ for $j \ne k$. Now choose a nite sequentially connected B A so that B^j B for j = 1/2/3.

We now choose connected neighborhoods W^j of y^j for j=1/2/3 such that $\overline{W^j} \setminus \overline{W^k} = j$ for $j \in k$.

We now show that the sequence $(g_i([B]))$ is null. For if not, then by Lemma 3 we may assume that there is a $B \ 2 \ B$ and $A \ 2 \ A$ such that $g_i(B) = A$ for all

i. Thus $h_i = g_i g_1^{-1} \ 2 \operatorname{Stab}(A)$. Letting $\mathbf{u}_i = g_1(\mathbf{v}_i)$ we have $h_i(\mathbf{u}_i) \ !$ \mathbf{w} and $\mathbf{u}_i \ !$ $g_1(\mathbf{v})$. By remark 1, this would imply that $\operatorname{Stab}(A)$ didn't act properly on 4X which is a contradiction. Thus the sequence $(g_i(\lceil B))$ is null and passing to a subsequence we may assume that $(g_i(\lceil B)) \ ! \ z \ 2 \ X$. (That is to say that for any neighborhood U of z, there is an M such that if i > M then $g_i(\lceil B) \ U$.)

Since $\overline{W^1}$, $\overline{W^2}$ and $\overline{W^3}$ are disjoint, we may assume $z \not \! D \overline{W^2} [\overline{W^3}]$, and so passing to a subsequence we may assume that $g_i([B] \setminus W^2 = j) = g_i([B] \setminus W^3]$. The point z is not a cut point of X. By Lemma 1, for i = 0, $g_i([B])$ does not separate W^2 from W^3 . (See gure 2.)

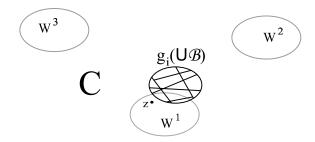

Notice that for i = 0, $g_i(x^j) \ge g_i(V^j) \setminus W^j \ne j$.

Thus for such a (very) survice ciently large i, $W^2 \[[W^3] \]$ is contained in a single component C of $X - g_i([B])$ and $g_i(V^2) \setminus W^2 \ne j \ne g_i(V^3) \setminus W^3$. This implies that $C = g_i(V^2)$ and $C = g_i(V^3)$ contradicting the fact that $V^2 \setminus V^3 = j$. \square

We will show that the theorem is false if the hypothesis that *A* is ne is removed.

Example Let G be the Kleinian reflection group generated by reflection in the sides of a regular right-angle hyperbolic dodecahedron. For each reflection $r \ 2 \ G$ let P_r be the plane in \mathbb{H}^3 xed by r. By standard results, the centralizer of r acts cocompactly on P_r . Let $H_r = \operatorname{Stab}(P_r) = \operatorname{Stab}(P_r)$ where P_r is the boundary circle of P_r in $S^2 = P_r$. Since P_r acts cocompactly on P_r , it follows that the limit set $P_r = P_r$. Notice that the Main theorem applies in this setting, as the collection of circles $P_r = P_r$. Notice that the Main theorem applies in this collection of circles gives one of the subdivision rules studied by Cannon, Floyd and Perry [4, pages 16{17}].

We now alter this example so that the collection A is no longer ne, and the action is no longer a convergence action, but all of the other hypothesis of the

Main theorem apply. By Baire's theorem, there is a point $s \ 2 \ S^2$ such that $s \ \not {\partial} \ {\partial} P_r$ for every reflection $r \ 2 \ G$. Choose a convergence sequence of distinct group elements $(g_i) \ G$ with $n \ \not {\partial} s$ such that for any compact $C \ \not {\partial} n$ and any neighborhood U of s, $g_i(C) \ U$ for all i >> 0.

Now let S be the set of translates of s by G. For each $t \ 2 \ S$, we replace the point t by the circle of directions \hat{t} at t (so \hat{t} is a circle of length 2). Rigourously let $\hat{S} = f\hat{t}jt \ 2 \ Sg$, and let $X = (S^2 - S) \ [\hat{S}$. We now describe the topology on X and show that G acts on X via homeomorphisms. There is the obvious "quotient" function $f \colon X \not S^2$ given by f(x) = x for $x \not B \ [\hat{S}$ and $f(\hat{t}) = ftg$ for $t \ 2 \ S$. To de ne the topology on X we describe a neighborhood basis of X. For $x \not B \ [\hat{S}$ and for U a neighborhood of f(x), $f^{-1}(U)$ will be a neighborhood of X.

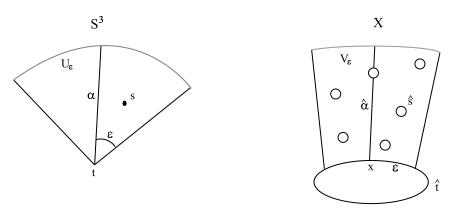

This gives a topology on X which is metrizable since X is regular and has a countable basis (S is countable). Since G acts conformally on S^2 , G preserves angles, and hence the action of G on S^2 "extends" to an action of G on X, and this action commutes with f, ie. for $g \ 2 \ G$, $g \ f = f \ g$.

Now for any reflection $r \ 2 \ G$, by de nition of s, $S \setminus @P_r = \gamma$. Thus $@P_r = X$ and it follows that the stabilizer H_r acts as a convergence on X.

However, G does not act as a convergence group on X, for our original convergence sequence (g_i) will have no convergence subsequence. To see this, let $c \ 2 \ X$ and take a closed annulus $D \ S^2$ separating n from s with $f(c) \ D$. Notice that by de nition of (g_i) , $g_i(D)$! s. Let $\hat{D} = f^{-1}(D)$, and notice that \hat{D} is compact. Clearly for any subsequence (g_{n_i}) of (g_i) , $g_{n_i}(\hat{D})$! \hat{S} . Since this is converging to an entire circle, it cannot converge to a single point, and so (g_{n_i}) is not a convergence sequence with repelling point c. Thus G does not act as a convergence group on X, even though the action of G on S satis es all of the hypothesis of the main theorem except that A is not no X.

We can alter this example slightly by gluing a disk into each of the circles \hat{t} , and obtain a new action of G on S^2 which is not a convergence action (neness still fails).
